PASSPORT COULD BE USED FOR ILLEGAL PURPOSES. FROM INFO NOT AVAILABLE TO HONDURANS, WE UNDERSTAND THAT ALVAREZ MAY HAVE RECENTLY RECEIVED A VISA IN A NEW PASSPORT IN PANAMA. WE WOULD APPRECIATE REPORT ON THIS FROM EMBASSY PANAMA. FROM DEPARTMENT VE REQUEST GUIDANCE AND LIAISON WITH INS. END SUMMARY © 3. CONTRARY TO INDICATIONS BY THE FORMIN (REPTEL) THAT HE WOULD NOT BE FORMALLY REQUESTING USG ACTION RE-ALVAREZ PASSPORT, EMBASSI RECEIVED DIPLOMATIC NOTE NO. 650-DSM ON SEPTEMBER 13, 1984, REQUESTING THAT THE USG ASSIST IN THE CONFISCATION OF GENERAL GUSTAVO ALVAREZ REGULAR PASSPORT NO. 163604. BELOW IS AN INFORMAL ENGLISH TRANSLATION OF THE DIPLOMATIC NOTE. THE MINISTRY OF FOREIGN RELATIONS OF HONDURAS PRESENTS ITS COMPLIMENTS TO THE HONORABLE EMBESSY OF O THE UNITED STATES OF AMERICA AND VITE INSTRUCTIONS OF THE APPROPRIATE AUTHORITIES, REQUESTS TO THAT DIPLOMATIC REPRESENTATION THAT THE COVERNMENT OF THE UNITED STATES, TEROUGE TEL APPROPRIATE AUTHORITIES. CONFISCATE REGULAR HONDURAN PASSPORT NO. 163604 LSSUED IN THE MONTH OF AUGUST OF THIS YEAR BY THE CONSULATES GENERAL OF HONDURAS IN MIAMI IN THE NAME OF MR. - 4. EMBASSY'S CONSULAR RECORDS SHOW THAT TWO VISAS WERE ISSUED TO GENERAL ALVAREZ IN DIPLOMATIC PASSPORT NO. 074, A-1 VISA FOUR YEARS MULTIPLE WAS ISSUED IN JULY 1983 AND B-2 VISA, FOUR YEARS MULTIPLE WAS ISSUED IN MAY 1983. WE DO NOT HAVE A RECORD OF ANY OTHER VISAS BEING ISSUED TO GEN. ALVAREZ BUT TOURIST VISAS IN A REGULAR. NON DIPLOMATIC PASSPORT COULD HAVE BEEN ISSUED TO HIM BEFORE 1983. RECORDS FOR EARLIER YEARS ARE RETIRED.
- FURTHER CO. TERSATIONS WITH GOH AUTHORITIES HAVE ELICITED ADDITONAL INFORMATION. ALVAREZ DIPLOMATIC PASSPORT WAS VALID ONLY FOR ONE YEAR AND PROBABLY HAS EXPIRED, OR WILL EXPIRE SHORTLY. ACCORDING TO HONDURANS HE ALSO HELD A REGULAR, NON-DIPLOMATIC PASSPORT, BUT REQUESTED A NEW ONE IN AUGUST IN MIAMI. THE NEW PASSPORT WHICH WAS ISSUED TO HIM IMPROPERLY IN MIAMI WITHOUT FOREIGN MINISTRY AUTHORIZATION, WAS A REGULAR PASSPORT, BUT IT IS NOT CERTAIN THAT IT WAS DULY AND FULLY FILLED IN WITH IDENTIFYING DATA. (ACCORDING TO ARMED FORCES CHIEF LOPEZ, THE PASSPORT MAY HAVE BEEN GIVEN TO HIM EN BLANCO, AND MIGHT THUS BE USED FOR INTRIGUE OR OTHER ILLEGAL PURPOSES.)
- 6. FROM SOURCES NOT AVAILABLE TO HONDURANS, HOWEVER, EMBASSY SUSPECTS ALVAREZ MAY IN FACT HAVE GOTTEN A FULLY IDENTIFIED REGULAR PASSPORT IN HIS OWN NAME FROM HONDURAN CONGEN IN MIAMI. WE UNDERSTAND THAT ALVAREZ APPLIED FOR AND RECEIVED A REPLACEMENT U.S. VISITORS VISA IN A NEW REGULAR PASSPORT IN PANAMA EARLY THIS MONTH, AND CLAIMED AT THE TIME THAT HIS PREVIOUS REGULAR PASSPORT HAD BEEN STOLEN.
- 7. FOR PANAMA: WE ARE SURPRISED THAT VISITOR'S

 VISA MAY HAVE BEEN ISSUED IN SUCH A POLITICALLY

 SENSITIVE CASE WITHOUT PRIOR CHECK WITH THIS EMBASSI.

 IF OUR UNDERSTANDING IS CORRECT, WE WOULD APPRECIATE

 AMPLIFYING INFO, INCLUDING PASSPORT NUMBER.
