1. ENTIRE TEXT)

DURING AMBASSADOR'S MEETING TODAY (SEPTEMBER 5) WITH FOREIGN MINISTER CARLOS JOSE GUTIERREZ, THE LATTER STATED THAT VICE MINISTER URBINA WAS LEAVING TOMORROW FOR PARIS FOR SECOND ROUND OF TALKS WITH NICARAGUANS ON POSSIBLE DMZ AGREEMENT. IN EXPLAINING THIS RATHER STARTLING MOVE, GUTIERREZ DESCRIBED IT AS PART OF GOCR'S BEING DOUBLY CAREFUL OVER CRITICAL NEXT FOUR MONTES TO AVOID PROVOCATION OF SANDINISTAS. ACCORDING TO HIS ANALYSIS, "CONTRA" ACTIVITY WILL SHARPLY INCREASE OVER THIS PERIOD MAKING POSSIBILITIES FOR BORDER INCIDENTS MUCH MORE LIKELY. HE EXPECTED THIS INCREASE BECAUSE CONTRAS RECOGNIZE THAT ELECTIONS, WHATEVER THEIR VALIDITY, WOULD SERVE TO SETTLE INTERNAL DIVISIONS IN THE FSLN AND PERMIT ORTEGA TO CONSOLIDATE IN THE MEANTIME, WHILE THE "U.S. IS HIS CONTROL. ARANOID OVER THE ELECTIONS", THE SANDINISTAS ARE PARANOID OVER THE POSSIBILITY OF AN INVASION. PARANOID OVER THE ELECTIONS" OF THIS MADE FOR AN ENVIRONMENT IN WHICH GOOR, GUTIERREZ STATED, COULD NOT AFFORD TO PROVOKE THE GRN.

WITH THE NICARAGUANS. IT WAS INTENDED TO CLARIFY A NUMBER OF POINTS, AND PREPARE GROUNDWORK FOR FURTHER DISCUSSION LATER IN THE YEAR. HE NOTED THAT GOCK WOULD RESIST CONCEPT OF INCLUDING EUROPEANS IN A POSSIBLE PEACEKEEPING FORCE IN THE DMZ. THEIR INCLUSION, COSTA RICANS HAD DECIDED, WOULD INEVITABLY THRUST THE EFFORT TOWARD UNITED NATIONS INVOLVEMENT WHICH GOCK WISHES AT ALL COSTS TO AVOID.

4. COMMENT: ALTHOUGH GUTIERREZ ASSURED AMBASSADOR THAT GOOR AND GRN WERE: "QUITE A WAYS" (BASTANTE LEJOS) FROM AN AGREEMENT, HE DID NOT PRECLUDE AN AGREEMENT BEING FINALIZED LATER IN THE YEAR. CONTRARY TO OUR PREVIOUS IMPRESSIONS FROM GOOR OFFICIALS, THE WAY THE FOREIGN MINISTER WAS TALKING A BILATERAL DMZ AGREEMENT IS A POSSIBILITY. FROM HIS ANALYSIS OF THE ANTI-SANDINISTA PROBLEM, GOOR MAY SEE SOME REAL ADVANTAGE IN HAVING SOME SUCH INTERNATIONAL MECHANISM TO PROTECT IT FROM BECOMING EMBROILED IN THE EPS/CONTRA CONFRONTATION IT SEES ON THE HORIZON.
