
SALVADORAN BATTALION

- ENTIRE TEXT.

THIS IS AN IMMEDIATE ACTION MESSAGE.

TWO HOUR SESSION WITH PRESIDENT, CARLOS FLORES. GENERAL LOPEZ AND COLONEL GONZALEZ MORNING AUGUST ONE ENDED INCONCLUSIVELY WITH RESPECT TO TRAINING OF NEXT SALVADORAN BATTALION AT RMTC STARTING AUGUST 3. (SEPTEL REPORTS MORNING MEETING.) AT END OF MEETING, WE AGREED THAT PRESIDENCY MINISTER FLORES AND AMBASSADOR WOULD BE IN TOUCH REGARDING NEXT STEPS.

- EARLY AFTERNOON FLORES CALLED IN AMBASSADOR TO INFORM HIM THAT GOH WAS AGREEABLE TO SALVADORAN BATTALION BEGINNING ITS TRAINING PROVIDED FOLLOWING CONDITIONS ARE MET:
- THAT SALVADORANS FORMALLY REQUEST TRAINING;
- B. THAT AN EQUAL NUMBER OF HONDURANS BE TRAINED SIMULTANEOUSLY. THIS WOULD BE EITHER IN THE FORM OF AN ENTIRE UNIT OR A COMBINATION OF A UNIT AND SELECTED INDIVIDUALS;
- C. THAT THE CENTER BE GIVEN MORE OF A REGIONAL ASPECT BY ALSO TRAINING OTHERS THERE. FLORES SPECIFI-CALLY MENTIONED COSTA RICAN POLICE.
- FLORES SAID THAT THIS WOULD BE A TRANSITIONAL ARRANGEMENT PENDING RENEGOTIATION OF RMTC TERMS OF REFERENCE AND MUTUALLY SATISFACTORY RESOLUTION OF SEVERAL OTHER ISSUES IMPINGING ON RMTC ISSUE. AMBASSADOR AND FLORES AGREED THAT SUCH DISCUSSIONS COULD REGIN NEXT WEEK ONCE WE HAVE HAD CHANCE TO STUDY GOH PAPER WHICH WAS GIVEN TO US IN MORNING MEETING. IN REPLY TO AMBASSADOR'S SPECIFIC QUESTION, FLORES ASSURED AMBASSADOR THAT GOH WISHED TO CONTINUE CONTRIBUTING TO THE TRAINING OF SALVADORAN BARMED FORCES OVER THE LONGER



TERM; BUT UNDER WHAT GOH CONSIDERS TO BE MORE EQUITABLE CONDITIONS AND BETTER OBSERVANCE OF CERTAIN HONDURAN SENSITIVITIES. THESE WOULD BE THE KINDS OF THINGS WE COULD TALK ABOUT NEXT WEEK.

6. AS OF FOR THE GOH CONDITIONS, AMBASSADOR RESPONDED THAT WE WOULD TRANSMIT THEM TO WASHINGTON AND OTHERS CONCERNED FOR A REACTION. AMBASSADOR OFFERED PERSONAL COMMENT THAT TRAINING COSTA RICAN POLICE SOUNDED LIKE IT MIGHT BE SOME SORT OF PROBLEM. AMBASSADOR RECALLED THAT THERE HAD BEEN SOME GUATEMALAN INSTRUCTORS AT RMTC AT ONE POINT AND THEIR RETURN MIGHT BE HELPFUL.

7. COMMENT AND ACTION REQUESTED: COMPARED TO EARLIER GOH POSITION THAT THEY DIDN'T WANT SALVADORAN BATTALION AT ALL UNTIL RMTC TERMS OF REFERENCE RENEGOTIATED AND UNTIL SOME PROGRESS ON BORDER ISSUE, PRESENT GOH CON-DITIONS REPRESENT AN IMPROVEMENT. THERE IS NOTHING IN PRINCIPLE WHICH STRIKES US AS UNACCEPTABLE ABOUT AGREE-ING TO THE TRAINING OF AN EQUAL NUMBER OF HONDURANS AS SALVADORANS THIS TIME AROUND. (THERE ARE ALREADY 400 HONDURAN NCO'S TRAINING THERE NOW; SO THE INCREASE NEEDED FOR PARITY WOULD NOT BE TOO GREAT.) NOR DO WE SEE ANYTHING UNREASONABLE ABOUT A FORMAL REQUEST BY GOES FOR TRAINING AT RMTC. AS FOR WIDER REGIONAL ASPECT, PERHAPS WE CAN COME UP WITH SOME FIELD TRAINING FOR PEO-PLE ALREADY AT USARSA OR REVIVE THE IDEA OF GETTING GUATEMALAN INSTRUCTORS BACK. IN ANY EVENT, WE THINK THIS LATTER CONDITION, THOUGH IMPORTANT TO GOH IN LONGER TERM, MAY NOT BE SC PRESSING AS PARITY IN NUMBERS AND FORMAL SALVADORAN REQUEST. PERHAPS A COMMITMENT TO

MAKE BROADER REGIONAL PARTICIPATION A FEATURE OF FUTURE TRAINING CYCLES MAY BE SUFFICIENT TO MEET HONDURAN CONCERN AT THIS TIME.
