INFORMATION MEMORANDUM FOR DOD AND DOS

This Information Memorandum outlines CPA's own current strategic vision for Iraq's transition to full sovereignty, particularly in respect of the sequencing of the three (3) basic documents — namely, the Fundamental Law, Security Agreement, and Treaty Restoring Sovereignty — and their interplay vis-a-vis the transition process and the future new Iraqi Constitution and governing institutions.

The Fundamental Law and Security Agreement would be prepared and executed at the very outset of the transition process – the Fundamental Law and the Security Agreement would be executed between the CPA and the Goveining Council on <u>February 28</u> and <u>March 31, 2004</u>, respectively.

The Fundamental Law would inter alia:

- Enshrine the basic principles of fundamental liberties and democracy;
- set the structure and process for electing and appointing both the Transitional National Administration and Transitional National Assembly;
- incorporate a Statement of Development Stirategy, and related actions Matrix, confirming Iraq's commitments to sound governance and socio- and macroeconomic frameworks; and
- incorporate [all] [certain] CPA Orders.

The Security Agreement would comprise inter alia::

- Military technical Assistance Agreement;
- Acquisition and Cross-Servicing Agreement; and
- Status of [U.S.] [Coalition] Forces Agreement.

Following execution of the Fundamental Law and Security Agreement, a Transitional National Assembly would be elected on <u>May 31, 2004</u>, and the Assembly would elect a Transitional National Administration <u>sometime in June 2004</u>.
