MEMORANDUM TO ALL NRO PERSONNEL

SUBJECT: Personal Profiles Authorized for the Initial Overt NRO Period

- 1. This letter provides interim guidance to all NRO government people concerning their personal profiles during the initial days of an overt NRO. I refer you to the referenced message which discusses the new overt NRO in detail.
- 2. When the existence of the NRO is openly acknowledged, there will initially be no change in how people acknowledge their affiliation with the NRO.

 This includes military and civilian personnel transactions, civil documentation such as loan applications, and social centros.

That is, they will only acknowledge NRO affiliation in SCI channels. In open situations, they will only acknowledge affiliation with their parent agencies. This includes military and civilian personnel transactions, civil documentation such as loan applications, and social settings.
- 3. In the near future, we will explore a policy that will allow our people to acknowledge their affiliation at less than SCI levels. No disclosure would be allowed in situations where there is potential for compromising the collection mission. Over the next month, we will set into place a mechanism for allowing a discrete spectrum of levels of acknowledgement for the various elements of the NRO. The levels will be based on an assessment of the risks of disclosure.
