THE EXPLOSION CAUSED DAMAGES ESTIMATED AT 2 MILLION PESOS. (4) (U) 870409 - SOURCE I REPORTS THAT A SOLDIER DIED IN AN ELN AMBUSH OF A SECOND BRIGADE PATROL IN THE AREA OF PUERTO CLAVER (b)(2) AND PUERTO LOPEZ (b)(2) HELICOPTER WAS FIRED ON BY ELN GUERRILLAS WHEN IT OVERFLEW THE

AREA OF THE AMBUSH. THE HELICOPTER MADE AN EMERGENCY LANDING AT THE MILITARY BASE IN EL BAGRE (b)(2) NO ONE WAS WOUNDED IN THE ATTACK ON THE HELICOPTER.

- (5) (U) 870410 SOURCE K REPORTS THAT FOUR ELN GUERRILLAS WERE KILLED DURING A CONFRONTATION WITH TROOPS BELONGING TO THE FIFTH BRIGADE IN THE VICINITY OF ARAUCA.
- CUCUTA (b)(2) NORTE DE SANTANDER), TROOPS OF THE 5TH BRIGADE CAPTURED HERNANDO LOPEZ AND VICTOR MANUEL OSPINA, MEMBERS OF THE "DOMINGO LAIN SAENZ" CUADRILLA, WHO WERE WOUNDED DURING THE ASSAULT ON PUERTO RONDON (ARAUCA) ON 870407. THEY ALSO CAPTURED LAUREANO MARTINEZ AND VILMA YANETH MARTINEZ TRASLAVINA, WHO ARRIVED FROM SARAVENA (ARAUCA) IN AN "SAS" AIRPLANE (REGISTRATION NUMBER HK-2877). THE WOUNDED GUERRILLAS WERE ISOLATED IN THE SAN JUAN DE DIOS HOSPITAL IN CUCUTA UNDER MILITARY GUARD. ACCORDING TO SOURCE P, IT WAS ONLY VICTOR MANUEL HOSSMAN WHO WAS WOUNDED; HE WAS BEING ACCOMPANIED BY HERNANDO LOPEZ AND BEING MET BY THE OTHER TWO GUERRILLAS. THE SOURCES DIFFER IN THE IDENTITY OF THE WOUNDED GUERRILLAS SOME IDENTIFY HIM AS VICTOR MANUEL HOSSMAN AND OTHER IDENTIFY HIM AS VICTOR MANUEL OSPINA.
- (7) (U) 870411 SOURCE M REPORTS THAT THREE SUSPECTED MEMBERS OF AN ELN CELL WERE KILLED IN MEDELLIN WHEN THEY TRIED TO ESCAPE FROM THE POLICE. THE POLICE ARRIVED AT THE HOUSE WHERE THEY WERE ARRESTED FOLLOWING A TIP FROM NEIGHBORS. WHILE THE POLICE WERE TRANSPORTING THE THREE MEN TO THE JAIL, THE POLICE VEHICLES WAS ALMOST INTERCEPTED BY THREE MOTORCYCLES AT THE SAME TIME THAT THE PRISONERS WERE TRYING TO DISARM THE POLICE. THE MEN ON THE MOTORCYCLES ESCAPED WITHOUT BEING IDENTIFIED.
- (9) (U) 870413 SOURCE N REPORTS THAT CARLOS OSSA ESCOBAR, PRESIDENTIAL ADVISOR FOR REHABILITATION, RECONCILIATION AND NORMALIZATION, SAID THAT MULTINATIONAL OIL COMPANIES HAVE FINANCED THE ELN BY PAYING THEM "FOR SECURITY" AND CHARGING THE COSTS TO THE CONSTRUCTION OF THE OIL PIPELINE. THIS CHARGE WAS MADE ON THE PROGRAM "EL PERSONAJE DE LA SEMANA", PRODUCED BY CARACOL. ON THE PROGRAM OSSA ESCOBAR SAID THAT THE ELN HAD BUILT ITSELF UP NOT BY VIRTUE OF THE PEACE PROCESS BUT BECAUSE THEY WERE GENEROUSLY FINANCED BY A MULTINATIONAL COMPANY WHICH OPERATES IN COLOMBIA, AND THAT THIS UNNAMED COMPANY HAD PAID MILLIONS OF DOLLARS TO THE ELN GUERRILLA ORGANIZATION. HE WENT ON TO SAY THAT THE COMPANY INCLUDED THOSE FUNDS AS PART OF THE COST OF THE CONSTRUCTION OF THE PIPELINE.
- (10) (U) 870413 SOURCE P REPORTS THAT ELN GUERRILLAS ATTACKED AND BURNED A RANCH NEAR TENERIFE. ACCORDING TO WORKERS AT THE RANCH, THE RANCH WAS ATTACKED BY ABOUT 50 ARMED MEN WHO STOLE TWO SHOTGUNS AND BURNED THE RANCH AND VARIOUS VEHICLES, INCLUDING A BULLDOZER VALUED AT 40 MILLION PESOS.

- (2) (C/NF) 870410 IN LA MILAGROSA. LOCATED IN THE MUNICIPALITY OF SANTA FE DE ANTIQUIA (D)(2) (ANTIQUIA), GUERRILLAS OF THE "PEDRO LEON ARBOLEDA" CUADRILLA MADE ARMED CONTACT WITH TROOPS OF THE 4TH BRIGADE WHICH RESULTED IN TWO SOLDIERS BEING WOUNDED AND 5 GUERRILLAS KILLED.
- (3) (U) 870411 SOURCE I REPORTS THAT MILITARY AUTHORITIES IN ANTIQUIA REPORT THAT A LARGE COLUMN OF EPL GUERRILLAS HAS BEEN DETECTED IN THE WESTERN PART OF THE DEPARTMENT OF ANTIQUIA. THE LAST SPOTTING OF THE GUERRILLAS WAS IN LAS AZULES, MUNICIPALITY OF SANTA FE DE ANTIQUIA, 79 KILOMETERS TO THE WEST OF MEDELLIN. SOURCE L REPORTS THAT FOUR GUERRILLAS, BELIEVED TO BE CNG MEMBERS, WERE KILLED BY TROOPS OF THE FOURTH BRIGADE IN THE SAME AREA. FOLLOWING THE BATTLE, GOVERNMENT FORCES SIEZED THE FOLLOWING MATERIAL:
 - A. ONE GALIL RIFLE
 - B. ONE FAL RIFLE
 - C. ONE R-15 RIFLE
 - D. TWO .30 M-1 CARBINES
 - E. ONE PAIR OF NIGHT VISION GOGGLES
 - F. 29 SETS OF FIELD GEAR.

SOURCE M REPORTS THAT TWO SOLDIERS WERE WOUNDED IN THAT SAME ENCOUNTER. THE GUERRILLAS WERE BELIEVED TO HAVE BEEN MOVING FROM URAMITA, 167 KILOMETERS FROM MEDELLIN. SOURCE Q INDICATES THAT IN ADDITION TO THE ABOVE MATERIAL, THE GOVERNMENT FORCES ALSO SIEZED 500 CARTBLOGES AND 17 FRAGMENTATION GRENADES.

THE BODIES OF THE THREE INDIVIDUALS WERE DISCOVERED ALONG THE ROAD BETWEEN FLORENCIA AND MORELIA. ALL THREE INDIVIDUALS WERE EX-MEMBERS OF THE M-19. THE VICTIMS HAD BEEN TORTURED BEFORE BEING KILLED. WHEN DISCOVERED, THE BODIES WERE STRIPPED AND THEIR HANDS AND FEET WERE TIED. THE DEAD MEN WERE IDENTIFIED AS ABEL AROCAS (STUDENT AT THE ANTONIO NARINO UNIVERSITY IN BOGOTA), LUIS CARLOS FELIX GASCA, AND ALBERTO N. ALL HAD RECEIVED AMNESTY FROM THE BETANCUR GOVERNMENT. 10. (U) 870405 - SOURCE C REPORTS THAT TWO PRISONERS WERE RESCUED BY THREE UNIDENTIFIED MEN, APPARENTLY GUERRILLAS. THE TWO INDIVIDUALS HAD BEEN ARRESTED BY POLICE ON 870404. THE RESCUERS ARRIVED IN A STOLEN TAXI WHOSE DRIVER HAD BEEN LOCKED INTO THE TRUNK OF THE CAR. THE TAXI WAS FOUND ABANDONED AFTER THE RESCUE. THE NAMES OF THE PRISONERS WERE SANCHEZ JIMENEZ (24 YEARS OLD) AND MONCAYO MILLAN (39 YEARS OLD). WHILE THEY WERE IN BEING DETAINED, THEY INSISTED ON MAKING AN URGENT TELEPHONE CALL. AUTHORITIES BELIEVE THAT THEY USED THE CALL TO NOTIFY THEIR PARTNERS WHERE THEY WERE BEING HELD. THE TWO MEN HAD BEEN ARRESTED AFTER WOUNDING ANOTHER TAXI DRIVER.
- 11. (U) SOURCE C ALSO CARRIES A REPORT ABOUT KIDNAPPINGS IN COLOMBIA DURING THE FIRST THREE MONTHS OF THE YEAR. IT SAYS THAT 62 PEOPLE WERE KIDNAPPED IN COLOMBIA DURING THE FIRST THREE MONTHS OF 1987. THE ELN AND THE FARC ARE THE GROUPS RESPONSIBLE FOR THE MAJORITY OF THESE KIDNAPPINGS, ACCORDING TO GOVERNMENT AUTHORITIES. (b)(2)

- (U) SOURCE C CARRIED ANOTHER ARTICLE TITLED "RUMORAN MATANZA DE 12 NARCOTRAFICANTES". ACCORDING TO THE REPORT, COLONEL DIEGO ANZOLA VASQUEZ SENT AGENTS, DISGUISED AS CAMPESINOS, TO EL LLANON IN THE JUNGLE ZONE OF SERRANIA DE PERIJA, WHERE, ACCORDING TO CAMPESINO RUMORS, 12 NARCOTRAFFICKERS HAVE BEEN KILLED BY GUERRILLAS WHICH OPERATE IN THAT AREA.
