1. (U) A "MAR" ATMOSPHERE CONTINUES TO PREVAIL IN COLOMBIAN JAILS AMONG IMPRISONED FOLLOWERS OF THE LATE NARCO KINGPIN GONZALO RODRIGUEZ GACHA (SEE REFTEL, PARA 3). INMATES GRABBED HOSTAGES AND TOOK OVER THE "LA PICOTA" JAIL IN BOGSTA, WHILE FIFTEEN ESCAPED FROM TWO DTHER PRISONS IN VALLE DEL CAUCA AND ANTIQUIA ON DECEMBER 25-26. CONFIDENTIAL

CONFIDENTIAL RODRIGUEZ GACHA GANG HELD ELEVEN GUARDS AND FOUR VISITORS HOSTAGE FOR SEVERAL HOURS. THE MUTINEERS THREATENED TO KILL THE HOSTAGES UNLESS THE MINISTER OF JUSTICE AND OTHER GOC OFFICIALS NEGOTIATED WITH THEM. THE GRIEVOUS WOUNDING OF A GUARD PROMPTED SPECIAL UNITS : OF THE METROPOLITAN POLICE TO STORM THE FACILITIES. POLICE MANAGED TO KILL SEVEN OF THE MUTINEERS AND RESCUED THE OTHER HOSTAGES, WHO EMERGED UNHARMED. DURING THE RIOT, THE INMATES ISSUED A DECLARATION. DEPLORING THE RECENT KILLINGS OF MEMBERS OF RODRIGUEZ GACHA'S GROUP. THEY ALSO EXPRESSED THEIR ALLEGIANCE TO MEDELLIN CARTEL CAPO PABLO ESCOBAR GAVIRIA. AUTHORITIES ARE INVESTIGATING THE MEANS BY WHICH THE PRISONERS GOT THE FIREARMS EMPLOYED IN THE RIOT.

- JAIL (VALLE DEL CAUCA IN THE SOUTHWEST) AND THE ZARAGGZA JAIL IN ANTIQUIA DEPARTMENT DECEMBER 26. ALL THE FUGITIVES WERE SERVING SENTENCES FOR MAJOR CRIMES AND POLICE IN BOTH DEPARTMENTS HAVE INSTITUTED MAJOR TRACKDOWN OPERATIONS TO RECAPTURE THEM
 - 4: (C) COLONEL JOSE LEDNIDAS CAMELO OF THE BOGOTA METROPOLITAN POLICE TOLD POLOFF DECEMBER 27 THAT THE LA PICOTA MUTINEERS WERE PROVIDED WITH FIREARMS BY CORRUPT PRISON GUARDS. CAMELO SAID THAT THE RODRIGUEZ GACHA FOLLOWERS RIOTED BECAUSE THEY PROBABLY BELIEVED THAT THE MEDELLIN CARTEL AND THE GROUP LED BY EMERALD TRAFFICKER VICTOR CARRANZA ARE OUT TO KILL THEM. ESCOBAR GAVIRIA, HE SAID, IS ANXIOUS TO PREVENT INCRIMINATION OF HIMSELF AND OTHER CARTEL MEMBERS BY FOLLOWERS OF RODRIGUEZ CONFIDENTIAL

GACHA, WHOM THEY BELIEVE WAS BETRAYED TO THE AUTHORITIES BY ONE OF HIS OWN GROUP. THIS IS THE REASON THAT THE RIOTING INMATES TRIED TO PLACATE ESCOBAR BY ISSUING A DECLARATION EXPRESSING ALLEGIANCE TO HIM, ACCORDING TO CAMELO. HE SAID THAT THE TWO PRISON ESCAPES STAGED DECEMBER 26 ARE PART OF JAIL-BREAKING EFFORTS BY OTHER IMPRISONED FOLLOWERS OF RODRIGUEZ GACHA WHO FEAR THERE IS A PLOT TO KILL THEM IN PRISON. CAMELO SPECULATED THAT THE LA PICOTA RIOT WAS THE RESULT OF THE FRUSTRATION OF INMATES AFTER FAILING TO STAGE A JAIL BREAK.
