## SITREP COVERING PERIOD 150600B JAN TO 170600B JAN 94.

I. GEN SITUATION. CALM. POPULATION GETTING ANXIOUS OF DELAY IN FORMATION OF BROAD HASED TRANSITIONAL GOVERNMENT.

#### II. PACTIONAL ACTIVITIES.

A. POLITICAL UN 16-876 LAW 94 MRND PARTY HOLD A POLITICAL MEETING AT RIGALI CITY, 5,000 TO 7,000 PEOPLE ATTENDED, SECURITY WAS FROVIDED BY MEMBERS OF THE PARTY HAVING NO VISIBLE ARGENEAT, SEMEARMERIE AND UNMOS WERD PRESENT, A CONFLICT OCCURRED AT THE REFUGEE CAMP 10 KM NORTH OF KIGALI, LOCAL POPULATION AND REFUGEES GOT STRUGGLED.

A. HOS. STAFF BRIEFING WAS CREANIZED FOR BRIG GEN ANYIDOHO FROM GHANA, DEFUTY FORCE COMD. HE ARRIVED IN THE MISSION AREA ON 15 JAN 94 AND WAS ACCOMPANIED BY 3 STAFF OFFR AND 1 OBSERVER. TODAY 17 JAN 94 TOTAL STRENGHT OF UNAMIR MILITARY DIVISION IS 1292.

#### B. SECTORS.

- (1) KIGALI. GENDUCTED VEHICLE AND FOOT PTL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. ESTABLISHED 4 CHECK POINTS AT DIFFERENT PLACES IN KWSA. CONDUCTED TWO ESCORTS FOR RPF. SECURED THE LOCATION OF THE RFF BATTALION IN KIGALI CITY, THE PREMATURE, FORCE HQ AND SEC HQ AND PROVIDED SECURITY TO THE AIRPORT OF KIGALI. DURING THE NIGHT ASSURED PROTECTION FOR THE FRIME MINISTER, THE PRIME MINISTER DESIGNATE. THE FRESIDENT OF THE CONSTITUTIONAL COURT AND FIVE OPPOSITION MINISTERS.
- (2) DMZ. FOLLOWING REPORTS OF TROOPS CONCENTRATION AT THE BORDER WITH UGANDA AND IN MFF AREA, EXTENSIVE MOBILE AND FOOT FIL MERE CARRIED OUT AT KIDAHO, KAGOGO, CYANIKA AND GITARE, NOTHING UNUSUAL WAS NOTICED. TARRIED GUT ONE LONG DISTANCE FIL ALONG BYUMBA, KIGALI, MANGMBE, MIKARANGE, GABIRO, NGARAMA AND MUVUMBA.

- C. MILOB. CONDUCTED ESCERTS FOR UNDER TO GATUNA. THE CONVOY WAS HINDERED AT THE REFUGEE CAMP 10 KM NORTH OF EIGALL.
- UNOWUR. THE MRA CONTINUES TO DEMONSTRATE A NON COOPERATIVE ATTITUDE TOWARDS THE PATROLS PARTICULARLY IN THE LUBIRIEL AREA. TWO EPS OFFICIERS (LITCOL AND MAJ) WERE RIDING ON MOTORCYCLE ON USANDAN TERRITORY AND WERE STOPPED BY A UNOMUR PIL.
