


- SUMMARY: POLITICAL DEATHS AND DISAPPEARANCES IN THE CITY OF AYACUCHO HAVE DECREASED DURING 1990. THE MILITARY SAID THAT IT HAS DEFEATED SENDERO LUMINOSO (SL) ON THE BATTLEFIELD; ALL THAT REMAINS IS SL'S POLITICAL AND SUPPORT STRUCTURE. OTHERS DISAGREED. AN SL-CALLED ARMED STRIKE COMPLETELY SHUT DOWN THE CITY THE DAY BEFORE POLOFFS' THREE-DAY VISIT. TWO "RUMORED" ARMED STRIKES SINCE HAVE FAILED TO MATERIALIZE. POLOFFS OBSERVED A TOWN WHICH ENTIRELY CLOSES ITS DOORS AFTER DARK. IN THE COUNTRYSIDE VIOLENCE APPEARS ABOUT THE SAME AS LAST YEAR, THOUGH ARMY-SPONSORED CIVIL DEFENSE GROUPS ("RONDAS CAMPESINAS") ARE TAKING A GREATER ROLE IN FIGHTING SL. PEASANT LEADERS COMPLAINED TO POLOFFS THAT THE RONDAS ARE LARGELY RUN BY THUGS AND NARCO-TRAFFICKERS, AND NOW COMMIT ABUSES IN THE ARMY'S STEAD. POLOFFS WERE ALSO TOLD OF SPECIFIC VILLAGES WHERE RONDAS LEADERS WERE ACTUALLY SL COMMANDERS.
- 3. AS ELSEWHERE IN RURAL PERU, THE ARMY AND POLICE ARE FEARED BY MUCH OF THE POPULATION. BUT MOST PEASANTS DO CONFIDE. T.AL



NOT SUPPORT SL, EXCEPT PASSIVELY. THREE CITY LEADERS
TOLD US THAT THE POLICE KIDNAP YOUNG MEN, ACCUSE THEM OF
TERRORISM, AND COLLECT RANSOM FROM THE PARENTS FOR THE
STUDENTS' RELEASE. THE VIOLENCE IN AYACUCHO HAS TAKEN
ITS TOLL ON ELECTED LEADERS. THE LAST ELECTED MAYOR WAS
KILLED BY SL IN SEPTEMBER, 1989; THE ACTING MAYOR IS ONE
OF THE SIX REMAINING (OF 21) COUNCILMEMBERS. AYACUCHO
DEPARTMENT - THE BIRTHPLACE OF THE SENDERO "REVOLUTION" IS IMPORTANT TO BOTH SL AND THE GOVERNMENT FOR
PSYCHOLOGICAL, NOT STRATEGIC, REASONS. BUT THAT DOES NOT
MAKE THE BATTLE TO CONTROL IT ANY THE LESS SAVAGE ON
EITHER SIDE. END SUMMARY.


- 4. THE CITY OF AYACUCHO HAS OFTEN PLAYED A SIGNIFICANT ROLE IN THE HISTORY OF PERU AND SOUTH AMERICA. IT WAS THE CAPITAL OF THE CONTINENT'S FIRST EMPIRE, THE PRE-INCA WARI CIVILIZATION. IT WAS THE BATTLE SITE THAT FINALLY DETERMINED THE PIZARRO BROTHERS' CONTROL OF THE PERUVIAN VICEROYSHIP. AND IN 1824, GENERAL JOSE DE SUCRE DEFEATED THE ROYALISTS IN THE BATTLE OF AYACUCHO, THE LAST GREAT BATTLE LEADING TO SOUTH AMERICAN INDEPENDENCE FROM SPAIN.
- 5. IF THE HOSTS OF ABIMAEL GUZMAN HAVE THEIR WAY THE CITY OF AYACUCHO WILL ALSO BE KNOWN TO ADMIRING FUTURE







CITY THE NUMBER OF DEATHS IS MARKEDLY DOWN THIS YEAR OVER 1989. ACCORDING TO THE CHIEF ICRC DELEGATE, THE NUMBER OF DISAPPEARANCES ATTRIBUTED TO THE MILITARY AND POLICE ARE ALSO DOWN IN THE CITY.

- 7. GENERAL FERNANDEZ-DAVILA ARGUES, AND THE RECENT NUMBERS SUPPORT HIM, THAT SL IS ON THE RUN IN AYACUCHO CITY (REF A). HE CLAIMED THAT SL'S MILITARY STRUCTURE IS DISMANTLED DEPARTMENT-WIDE AND THAT ONLY THE POLITICAL ORGANIZATIONS AND THE SUPPORT GROUPS REMAIN. OTHER INTERLOCUTORS AGREED THAT SL ATTACKS IN AND AROUND AYACUCHO CITY ARE DOWN. BUT THESE NON-MILITARY OBSERVERS OF SL DO NOT AGREE WITH THE GENERAL THAT SL IS WEAK IN THE DEPARTMENT. THEY POINT TO SOME DISTURBING FACTS.
- 8. ON SUNDAY, DECEMBER 2, TWO DAYS BEFORE POLOFFS' ARRIVAL, A COLUMN OF 50 SL ATTACKED A GAS STATION IN THE CITY. THE FIFTY WERE HEAVILY ARMED. WITNESSES DESCRIBED AUTOMATIC WEAPONS, DOUBLE BANDOLEROS AND NEW UNIFORMS. THE ATTACK WAS AT 1900 HOURS, IN DAYLIGHT, SIX BLOCKS FROM THE CENTRAL PLAZA. THERE WAS NO MILITARY OR POLICE RESPONSE. THE STATION BURNED TO THE GROUND AND SL LEFT WITHOUT A LOSS. THE ICRC DELEGATE TERMED THE ATTACK THE MOST BRAZEN HE HAD SEEN IN THE CITY ALL YEAR.









02 OF 07 PAGE 03 LIMA 19145 201706Z 9. THE NEXT DAY, MONDAY, DECEMBER 3, SL ORDERED AN ARMED STRIKE IN HONOR OF ABIMAEL GUZMAN'S BIRTHDAY. THE CITY OF AYACUCHO SHUT DOWN. ALL PRIVATE BUSINESSES CLOSED. SO DID SCHOOLS, BANKS AND GOVERNMENT OFFICES, INCLUDING THE MUNICIPALITY. THERE WAS ABSOLUTELY NO TRANSPORTATION, PUBLIC OR PRIVATE. ACCORDING TO THE MAYOR, THE MILITARY AND POLICE WERE ALSO LARGELY ABSENT. BUT SEVERAL POLICE POLOFFS SPOKE WITH EXPLAINED THE REASONS WHY THEY STAY OFF THE STREETS DURING ARMED STRIKES. THERE ARE ACTUALLY FEW SECURITY INCIDENTS DURING STRIKES. INSTEAD, SL TARGETS STRIKE-BREAKERS IN THE WEEKS AFTER THE STRIKE. POLICE PATROLS ONLY INVITE UNNECESSARY SL RETALIATION.

- 10. COMMENT: AYACUCHO ARCHBISHOP FREDERICO RISTER OBSERVED, AND OTHERS AGREED, THAT SL ARMED STRIKES HAVE BEEN TRANSFORMED BY AYACUCHO'S CITIZENS INTO A KIND OF COMMUNITY CELEBRATION. EVERYONE STAYS HOME. THERE IS NO ELECTRICITY BECAUSE SL BLOWS DOWN THE POWER LINES. SO INSTEAD OF WATCHING TV THE CITY MOVES ONTO THE STREETS FOR SOCCER, VOLLEYBALL AND VISITING NEIGHBORS. THE ART OF STREETCORNER STORYTELLING HAS BEEN REVIVED. BUT THE THREAT IS EXPLICIT AND UNDERSTOOD. SL RETALIATES AGAINST ANY OFFICIAL OR COMMERCIAL ACTIVITY. IT MAY BE A COMMUNITY CELEBRATION, BUT THERE ARE NO SHOPS OPEN TO TAKE ADVANTAGE OF THE VACATIONING POPULATION. END COMMENT.
- 11. (POST-TRIP UPDATE: TWO SUBSEQUENT "RUMORED" ARMED STRIKES CALLED IN THE 10 DAYS FOLLOWING POLOFFS' VISIT FAILED JO MATERIALIZE. WE WERE TOLD BY VISITORS FROM



12. AT POLOFFS' ARRIVAL, THE CITY WAS IN ITS FIFTH STRAIGHT DAY OF NO ELECTRICITY. BOTH NIGHTS OF THEIR STAY, BY 2030 HOURS, THE BUSY TOWN HAD BECOME A VIRTUAL GHOST TOWN. NO ONE WALKED THE STREETS. FOLKS POLOFFS SOUGHT APPOINTMENTS WITH, INCLUDING THE ICRC, WOULD NOT WALK SIX BLOCKS TO THE TOURIST HOTEL (JUST OFF THE PLAZA DE ARMAS) FOR APPOINTMENTS AFTER DARK. BY 2200 HOURS, POLICE AND MILITARY PATROLS HAD ALSO CEASED. STRANGE BEHAVIOR IN A CITY WHERE SL IS REPORTEDLY ON THE RUN.

#### A RURAL CIVIL DEFENSE STRATEGY GONE AWRY


13. IN THE COUNTRYSIDE THERE IS A DIFFERENT ATMOSPHERE AND AN ADDITIONAL PLAYER, THE ARMY-SPONSORED "RONDAS CAMPESINAS" (VILLAGE CIVIL DEFENSE PATROLS). IN POLOFFS' MEETINGS WITH AYACUCHO RESIDENTS, EVERY DISCUSSION ON TERRORISM, HUMAN RIGHTS, OR NARCOTICS IN RURAL AYACUCHO CENTERED ON THE RONDAS. ON BALANCE, ALL NON-MILITARY CONTACTS WE SPOKE WITH IN AYACUCHO (INCLUDING THE COPS) SAID THAT THE MILITARY STRATEGY TO MOBILIZE CIVILIANS IN THE COUNTRYSIDE HAD GONE DANGEROUSLY AWRY.




15. ACCORDING TO CODECSA SECRETARY GENERAL FRANCISCO MENDOZA, THE RONDAS LEADERS IN RURAL AYACUCHO ARE NOT LOCAL COMMUNITY LEADERS, BUT ARE MEN WHOSE AUTHORITY IS BASED SOLELY ON THE ARMY'S SUPPORT. MOST, HE SAID, ARE





CRIMINALS AND THUGS. IN THE PROVINCES OF LA MAR AND HUANTA THESE LEADERS CONTROL COCA LEAF PRODUCTION AND ARE SUPPORTED BY THE MILITARY LARGELY IN RETURN FOR SHARING COCA PROFITS.

16. A FEW RONDAS LEADERS IN THE SIERRA ARE SENDERO LUMINOSO MILITARY COMMANDERS. MENDOZA AND THE CODECSA HUMAN RIGHTS COORDINATOR RELATED TO POLOFFS THE STORY OF ANCOS VINCHOS VILLAGE, A SMALL TOWN EAST OF AYACUCHO. THE ARMY LEARNED THERE WAS AN SL BASE CAMP NEARBY AND THAT VINCHOS VILLAGERS WERE USED AS FORCE MULTIPLIERS IN ATTACKS AGAINST POLICE STATIONS AND ARMY PATROLS. THE CODECSA LEADERS ADMITTED THAT MANY IN VINCHOS WERE SL SYMPATHIZERS. THE ARMY ATTACKED THE VILLAGE IN EARLY 1990, KILLING SEVERAL MEN WHO REFUSED TO DIVULGE THE LOCATION OF THE SL BASE CAMP.

17. THE LOCAL SL COMMANDER GOT WISE. HE ROUNDED UP FOUR VINCHOS MEN AND HAULED THEM OFF TO THE MILITARY BASE AT HUANTA. "THESE ARE SL TERRORISTS," THE VINCHOS LEADER STATED TO THE BASE COMMANDER. "IF YOU WILL LEAVE MY VILLAGE ALONE I WILL CONTINUE TO BRING YOU TERRORISTS." AS THEY HAVE IN DOZENS OF OTHER VILLAGES, THE ARMY AGREED, IN THIS CASE NOT KNOWING THAT THEY WERE SUPPORTING AN SL MILITARY CELL LEADER WHO WAS BRINGING THEM NON-SL PRISONERS. VINCHOS IS NOW DESCRIBED BY THE ARMY AS A PACIFIED VILLAGE.





VILLAGERS HAVE BEEN ASSASSINATED SINCE FEBRUARY, 1989. A REFUGEE FROM IQUICHEZ TOLD POLOFFS THAT THE ARMY AND RONDAS ARE KILLING HIS PEOPLE. HE CLAIMED THAT SEVERAL IN THE TOWN WERE SL AND PARTICIPATED IN AN ATTACK ON AN ARMY PATROL NEAR THEIR VILLAGE IN JANUARY, 1989. SINCE THEN THE ARMY HAS BEEN COMING BACK EVERY TWO OR THREE WEEKS.
