I DISCUSSED WITH MFA SECRETARY GENERAL SOUTOU AUGUST 25 THE PUBLIC SURFACING OF THE FRENCH REFUSAL TO PROCEED WITH THE RE-PROCESSING DEAL. SOUTOU SAID THERE IS UNDERSTAND THAT THE FRENCH WILL FURTHER DELIVERIES FOR THE PLANT. SOUTOU REAFFIRMED SEVERAL DAYS AGO TO THE PAKISTANI AMBASSADOR THAT THE MEANING OF THE GISCARD LETTER TO ZIA WAS: NO TO THE

REPROCESSING PLANT. THE PAKISTANIS HAVE GIVEN THE FRENCH NO REACTION TO THE GISCARD LETTER OTHER THAN ZIA'S PUBLIC COMMENTS. THE FRENCH BELIEVE THAT PAKISTAN WILL TRY TO LIMIT, THE DAMAGE TO THE BILATERAL RELATIONSHIP AND WILL THEREFORE NOT RETALIATE AGAINST FRANCE IN THE ECONOMIC SPHERE. SOUTOU EXPECTS THE NEXT STEP TO BE A PRESENTATION BY PAKISTAN TO FRANCE OL A BILL FOR INDEMNIFICATION. END SUMMARY.



- 2. I REGAN BY NOTING THAT THE PRESS PLAY IN FRANCE HOD BEEN VERY FAVORABLE TO THE GOF (REFTEL). SOUTOU WHOLEHEARTEDLY AGREED. SOUTOU THEN CHARACTERIZED ZIA'S LETTER TO GISCARD AS VERY TOUGH AND EVEN INSOLENT. HE SAID IT WAS LUCKY THE ORIGINAL HAD BEEN WRITTEN IN ENGLISH; IF IT HAD BEEN IN FRENCH, IT WOULD HAVE PROVUKED A MUCH MORE NEGATIVE REACTION ON THE PART OF THE GOF.
- J. SOUTOU THEN DESCRIBED GISCARD'S RESPONSE AS FOLLOWS. THE FRENCH ARE CONVINCED THAT PAKISTAN MUST PLAY AN IMPORTANT ROLE IN THE REGION AND WANT TO COOPERATE CLOSELY BILATERALLY. RELATIONS MUST BE BASED ON TRUST, BUT IN A NUCLEAR WORLD THAT'S NOT ENOUGH. THERE IS A NEED TO SUBMIT CERTAIN INTERESTS TO HIGHER CONSIDERATIONS. COMMERCIAL COMMITMENTS HAVE TO TAKE A BACKSEAT TO COMMITMENTS THAT AFFECT HUMANITY. SOUTOU SAID THAT THE RESPONSE WAS VERY CLEAR: THE FRENCH HAVE DECIDED TO TERMINATE THEIR EXPORTS FOR THE REPROCESSING PLANT, SOUTOU UNDERLINED THIS POINT IN A MEETING WITH THE PAKISTANI AMBASSADOR SEVERAL DAYS AGO.

 PAKISTAN WOULD NOT CONTINUE. SOUTOU NOTED WRYLY
 THAT ZIA'S PRESS STATEMENT WASN'T MUCH HELP. THERE. I
 ALSO SAID THAT AMBASSADOR HUMMEL'S RECENT TALK WITH

TO ANY PREVIOUS DISCUSSIONS ABOUT THE US HELPING IN THIS REGARD. SOUTOU REPEATED THAT THE PAKISTANIS HAVE MADE NO THREATS. I ASKED WHETHER HE EXPECTED ANY ECONOMIC RETALIATION: HE REPLIED THAT THE PAKISTANIS SEEM TO WANT TO PRESERVE RELATIONS IN OTHER AREAS.

7. SOUTOU CONCLUDED BY MAKING THE GENERAL COMMENT, UNAMPLIFIED, THAT THERE WAS NOW A NEED TO HELP THE FRG TO BE MORE REASONABLE WITH REGARD TO BRAZIL. HARTMAN
