This partial denial is in accordance with Title 5 U.S.C. 552 (b)(6) of the FOIA. This partial denial, which is made on behalf of Major General Donald J. Ryder, Commander, USACIDC, who is the Initial Denial Authority for USACIDC records under the FOIA, may be appealed to the Secretary of the Army. If you decide to appeal at this time, your appeal must be submitted within 60 days of the date of this letter. In your appeal, you must state the basis for your disagreement with the denial, and you should state the justification for release of the portions of the requests that were withheld. Please note an appeal may not include a new request for information. It should only address information withheld in this response. Your appeal is made through this center and should be addressed to the Director, U.S. Army Crime Records Center, Attention: Freedom of Information/Privacy Act Division (F03-2068), 6010 6th Street, Building 1465, Fort Belvoir, Virginia 22060-5585, for forwarding, as appropriate, to the Office of the Secretary of the Army.

The status of our ten oldest pending requests is being provided for your information.

The initial request was denied, however, we held this request in abeyance pending completion.
