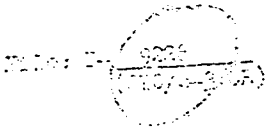

1. Reference is made to your SAC/AFS/AL/PT.3699 dated Dec. 8, 1945.
2. Exhaustive enquiries made in Celle reveal that DANNECKER, after working in HOYER, Kreis Celle from Sept. 27 1945 to Nov. 23, 1945, revealed to a sister-in-law resident in Celle that on November 29th 1945 he was leaving for BAD TOLL, where his address would be:
Ludwigstraße 27 or 28,
BAD TOLL, Bavaria
3. Since he left Celle, his afore-mentioned relative received a letter from him saying that he was staying for a time with Dr. DANNECKER (his brother), ARMIN, Kr. KARTHENITZ. He added that he hoped to be in BAD TOLL for Christmas. This is the last news she has had from him.
4. Photographs of DANNECKER and his wife are attached, together with group photographs showing him accompanied by others with whom he worked in SOFIA.
5. DANNECKER was born on 27th March 1913, at FUEHNROE, WURTTEMBERG, Neckargassestraße 4. He married in Paris in 1941. He joined the NSDAP before 1933, and was also in the S.S (rank Hystufu). From the commencement of the war he worked in the rounding-up of Jews in other countries, and their transportation to Germany. In 1939 and 1940 he was in Poland; from 1940 to 1942 in Paris. In 1944 he was in Hungary and Sofia. At the end of 1944 he returned to Berlin, where he stayed until the capitulation. Here, it is believed, he was interviewed by Hitler along with other high-ranking officers, and received his last order, which was for the organization of the VERMOEG. In this capacity he was sent to SCHAEFEN, North Germany.
6. Staff Pink card 89413-9 refers.
7. When subject left Celle he was wearing a light raincoat, green soft hat, grey suit, and brown shoes. He was carrying a ruck-sack and small suitcase.
8. It is hoped that the above details will enable the U.S. authorities to locate and arrest DANNECKER!
