RE: EICHMANN CASE.

1. COMAY (ISRAEL) CALLED ON ME THIS AFTERNOON TO DISCUSS FORTH-
COMING SC. AMB REID WAS HERE AND PARTICIPATED IN MEETING.
2. COMAY SAID ISRAEL WOULD TAKE MODERATE POSITION IN SC. HE
NOTED ANY RES WOULD CONTAIN REFERENCE TO BACKGROUND OF EICHMANN
AND THAT ACTION PARA WOULD CALL FOR EFFORTS TO BRING ABOUT
NORMAL RELATIONS. RES SHOULD NOT CALL FOR RETURN OF EICHMANN,
AS THIS WAS IMPOSSIBLE FOR ISRAEL, AND WOULD CAUSE GREAT EMOTIONAL
DISTURBANCE.
3. HE SAID ISRAEL DID NOT BELIEVE NORMAL NEGOTIATION PROCESS AS
HAVING BEEN COMPLETED; ARGENTINA HAD SUDDENLY GIVEN ISRAEL
CERTAINITY AND BROUGHT ISSUE TO SC. ISRAEL STILL WANTED TO
QUESTION OUT AND RESTORE REGULAR CORDIAL RELATIONS WITH
ARGENTINA AND THOUGHT THIS COULD BE DONE.
4. I SAID I ALSO THOUGHT IT COULD BE DONE BUT THAT THIS WOULD
TAKE SOME INITIATIVE BY ISRAELIS, NOT NECESSARILY CONCESSION BUT
WILLINGNESS TO TALK. I SAID BEN-GURION AND FRONZIZI WERE IN EUROPE
AND THIS SEEMED TO BE LOGICAL OPPORTUNITY. COMAY SAID
ESSENTIALLY THAT BEN-GURION WAS WILLING TO TALK TO FRONZIZI
AND TO TAKE INITIATIVE. HE REFERRED TO FACT ARGENTINA AND ISRAEL
HAD MANY MUTUAL FRIENDS AND CONTACTS AND SAID DISCREET
EFFORTS WERE UNDER WAY TO SEE IF SOMETHING COULD BE ARRANGED.
