1. LYON CONVEYED PURPORT REPTEL TO DEL SOLAR THIS AFTERNOON WHO TOOK CAREFUL NOTES

2. SOLAR TELEPHONED PRESIDENT FRONDIZI IN BERN CONVEYING MESSAGE

3. PRESIDENT FRONDIZI STATED THAT:

A) AMADEO, UN, RECEIVING INSTRUCTIONS THAT IF THIRD COUNTRY (ANY THIRD COUNTRY) REQUESTS THAT SECURITY COUNCIL MEETING 22ND BE POSTPONED, ARGENTINE REP SHOULD NOT OPPOSE BUT ACCEPT

B) PRESIDENT FRONDIZI STATED HE IS DOING THIS BECAUSE OF OUR REQUEST TO HIM AND THEREFORE ASKS THAT US UNDERTAKE WORK OF ARRANGING FOR SUCH THIRD COUNTRY PROPOSAL. RECOMMENDATION FOR POSTPONEMENT SHOULD NOT BE FOR INDEFINITE PERIOD, THAT WOULD BE TOO OBTUSOUS, BUT SHOULD BE FOR LIMITED PERIOD

C) PRESIDENT FRONDIZI WOULD SEE MR. BEN GURION IN LATER REQUESTS THIS AGAIN LACKING BACKGROUND AND HAVING TALKED WITH FRONDIZI ONLY BY TELEPHONE DEL SOLAR WAS NOT VERY PRECISE ON THIS. FOR EXAMPLE HE WAS NOT CERTAIN WHETHER FRONDIZI INSISTED ON A REQUEST FROM BEN GURION OF THE A-THIRD

COUNTRY INFORMED BOTH MR. BEN GURION AND MR. FRONDIZI THAT THE OTHER WAS PREPARED TO MEET WHETHER THIS WOULD SUFFICE. HE IS ASKING FOR PRECISE INSTRUCTIONS ON THIS.

D) MEETING TO TAKE PLACE EITHER IN FRANCE OR BELGIUM (OBVIOUSLY IT WOULD HAVE TO BE IN BELGIUM AS BEN GURION HAS LEFT FRANCE. FRONDIZI WILL BE IN PARIS JUNE 22-23, LEAVE FOR BELGIUM JUNE 24, BRUSSELS 24-25, LEAVE FOR BONN 26TH.)

4. ARGENTINE WILL HERSELF MAKE NO MOVE ALONG THESE LINES, BUT THERE IS MUCH GOOD-WILL AND GOA WILL RESPOND TO THIRD COUNTRY MOVES MENTIONED ABOVE. HOWEVER, IF QUESTIONED BY PRESS, PRESIDENT FRONDIZI WILL HAVE TO DENY HE IS PLANNING MEETING WITH MR. BEN GURION, ETC.

5. JOEL SOLAR HAS RECEIVED FURTHER INSTRUCTIONS FROM PRESIDENT FRONDIZI SAYING HE WOULD LIKE TO HAVE DETAILS OF ABOVE WORKED OUT WITHIN FRAMEWORK OF UN, I.E. AMONG DELEGATES AT UN.

6. AMBASSADOR THIS AFTERNOON MET WITH ISRAELI AMBASSADOR AND DISCUSSED DEPTTEL 5391. ISRAELI AMBASSADOR INDICATED THAT HE UNDERSTOOD THAT PRESIDENT FRONDIZI WOULD BE AGREEABLE TO HOLDING MEETING WITH BEN GURION IF THIS WERE PROPOSED BY THIRD COUNTRY.
