FEBRUARY 17 COCA COLA PLANT CLOSURE IN GUATEMALA CITY AND ITS CONSEQUENCES FOR THE WORKERS AND THE TRADE UNION. AFTER THEIR ARRIVAL, THE DELEGATION ALSO ASKED FOR INFORMATION ABOUT SEVERAL MISSING TRADE-UNION LEADERS FROM A LIST SUPPLIED BY PAT DERIAN. ALL OF THESE ABDUCTED UNION LEADERS ARE FROM THE LEFTIST CNT (CENTRAL NACIONAL DE TRABAJADORES), AND FROM THE TRADE UNION AT THE CAVISA GLASS FACTORY. THE CAVISA UNION IS AN AFFILIATE OF THE COMMUNIST TRADE-UNION FEDERATION FASGUA (FEDERACION AUTONOMA SINDICAL DE GUATEMALA). DURING THEIR SOJOURN IN GUATEMALA, THE DELEGATION MET WITH THE FOREIGN MINISTER, THE MINISTER OF LABOR, OFFICERS OF CUSG (CONFEDERATION OF SYNDICALIST UNITY OF GUATEMALA), TRADE-UNION LEADERS FROM COCA COLA AND SOME TWENTY OTHER UNIONS, THE MINISTER OF THE INTERIOR, A PRIVATE-SECTOR REPRESENTATIVE, EMBASSY OFFICERS, AND THE AIFLD DIRECTOR. THEIR VERDICT WAS THAT WHILE THEY WERE CONVINCED THAT THE PERSONAL SECURITY OF THE COCA-COLA WORKERS WAS NOT IN JEOPARDY AND THAT THE COMPANY HAD INDEED SUFFERED FROM BAD MANAGEMENT, RECENT DISAPPEARANCES OF NUMEROUS TRADE-UNION LEADERS DEMONSTRATED A BASICALLY NEGATIVE ENVIRONMENT FOR THE TRADE-UNION MOVEMENT IN GUATEMALA. ALTHOUGH THE EMBASSY ARRANGED FOR SOME OF THE APPOINTMENTS FOR THIS PRIVATE DELEGATION (SEE REFTTEL A), EMBASSY OFFICERS WERE PRESENT ONLY AT THE EMBASSY BRIEFING, THE MEETING WITH CUSG LEADERS, AND

PATTERSON, THE DELEGATION DEPARTED GUATEMALA ON MARCH 29. MR. PATTERSON SUBSEQUENTLY MET WITH THE AIFLD DIRECTOR AND INDICATED THAT THE DELEGATION'S NEXT STEP WOULD BE TO MEET WITH COCA-COLA OFFICIALS IN ATLANTA. END SUMMARY.

(2) JOSE LOPEZ BRAN, MEMBER OF PANTALEON SUGAR MILL WORKERS UNION. RELATIVES, AND THE EMPLOYERS, DENOUNCED HIS ABDUCTION WITH MIGUEL GOMEZ, ALSO IDENTIFIED AS LABOR LEADER. THEY WERE LAST SEEN ON NOVEMBER 27, 1983 IN SANTA LUCIA COTZUMALGUAPA, ESCUINTLA. THEY ARE STILL MISSING.

(3) JOSE GUILLERMO GARCIA, MIRANDILLA SUGAR MILL WORKERS UNION, ESCUINTLA. MISSING SINCE JANUARY 26, 1984. RELATIVES DENOUNCED HIS KIDNAPPING TO PRESS ON JANUARY 30, 1984. STILL MISSING.

(4) ALEJANDRO DEL CID, DIRECTOR MIRANDILLA SUGAR MILL WORKERS UNION, ESCUINTLA. MISSING SINCE JANUARY 26, 1984. HIS RELATIVES CHARGED UNIDENTIFIED INDIVIDUALS WITH HIS ABDUCTION ON JANUARY 30. THEY ALLEGED THAT HE AND JOSE GUILLERMO GARCIA WERE KIDNAPPED TOGETHER.

(5) ALFONSO ALVARADO PALENCIA, CNT LABOR LEADER, WAS KIDNAPPED IN GUATEMALA CITY ON JANUARY 26, 1984. CNUS, IN A REPORT FROM HAVANA, ASSERTED THAT HIS BODY AND THAT OF A GLASS FACTORY WORKER (SEE NO. 7 BELOW) WERE FOUND TORTURED AND SHOT. LOCAL PRESS STILL HAS HIM AS MISSING.

(8) LIC. SANTIAGO LOPEZ AGUILAR, LABOR LAWYER, WAS KIDNAPPED IN GUATEMALA CITY ON FEBRUARY 16, 1984. HIS BODY -- WHICH EXHIBITED SIGNS OF TORTURE -- WAS FOUND ON FEBRUARY 21 WITH A NOTE: "EXECUTED FOR TREASON - PGT".

(9) ON FEBRUARY 2, UNIDENTIFIED INDIVIDUALS ABDUCTED SERGIO MANFREDO BELTETON DE LEON. (NOTE. EMBASSY ASSUMES THIS IS THE "SERGIO" MENTIONED IN THE GUATEMALAN HUMAN RIGHTS COMMISSION REPORT (SEE NO. 6 ABOVE). IN ADDITION TO BEING A LAW STUDENT, THIS REPORT IDENTIFIED HIM AS A CNT LEGAL ADVISER. HIS ABDUCTORS RELEASED HIM ON FEBRUARY 17.

ON MARCH 1, FASGUA LEGAL COUNSEL VICTOR HUGO QUINTANILLA WAS ABDUCTED; HIS WHEREABOUTS REMAIN UNKNOWN.

ON MARCH 8, INTERNATIONAL PRESS (EFE) REPORTED THAT THE CENTRAL SUGAR FEDERATION OF THE DOMINICAN REPUBLIC HELD A PROTEST RALLY IN FRONT OF THE GUATEMALAN EMBASSY IN SANTO DOMINGO TO DENOUNCE THE KIDNAPPING IN GUATEMALA OF FIVE SUGAR WORKERS (JOSE GUILLERMO GRAN, MIGUEL ANGEL GOMEZ, JOSE GUILLERMO GARCIA, ALEJANDRO DEL CID, AND SERGIO MANFREDO HERNANDEZ).

THE EMBASSY ALSO PROVIDED THEM WITH THE FOLLOWING INFORMATION ON THE TRADE-UNION CONNECTIONS OF THE GENTLEMEN IN QUESTION:

FASGUA (FEDERACION AUTONOMA SINDICAL DE GUATEMALA/AUTONOMOUS TRADE UNION FEDERATION OF GUATEMALA) IS THE COMMUNIST TRADE-UNION FEDERATION IN GUATEMALA; IT IS A LEGALLY RECOGNIZED FEDERATION. IT WAS THE TRADE-UNION ARM OF THE OFFICIAL GUATEMALAN COMMUNITY PARTY (PGT) WHEN THAT PARTY WAS LEGAL. THE CAVISA UNION IS A FASGUA AFFILIATE.

CNT (CENTRAL NACIONAL DE TRABAJADORES/NATIONAL CENTRAL ORGANIZATION OF GUATEMALAN WORKERS) WAS FOUNDED IN THE 1960'S BY CHRISTIAN DEMOCRAT TRADE-UNION ORGANIZERS AND IT WAS AN AFFILIATE OF CLAT (THE CHRISTIAN DEMOCRAT REGIONAL ORGANIZATION FOR LATIN AMERICA). IN 1978, MARXIST-LENINISTS WHO HAD TAKEN OVER THE CNT TOOK IT OUT OF CLAT. THE CNT HAS NEVER APPLIED FOR LEGAL RECOGNITION AND HAS ALWAYS WORKED OUTSIDE THE LABOR LAW PROVISIONS OF GUATEMALA.

CNUS (CONSEJO NACIONAL DE UNIDAD SINDICAL/NATIONAL COUNCIL FOR TRADE UNION UNITY) IS AN UMBRELLA TRADE-UNION ORGANIZATION. FOR ALL INTENTS AND PURPOSES, IT IS NOT FUNCTIONING

-- THE COCA-COLA UNION WAS NOT A PART OF CUSG AND HAD REBUFFED ALL CUSG OVERTURES;

-- THE COCA-COLA UNION HAD RESPONDED TO CUSG INITIATIVES BY REITERATING ITS DESIRE TO REVIVE THE CNT AND THE CNUS;

-- THE CUSG, IN SPITE OF SUCH REJECTIONS, HAD PUBLICLY EXPRESSED ITS SUPPORT OF THE COCA-COLA WORKERS AND UNION AFTER THE FEBRUARY PLANT CLOSURE;

-- CUSG LEADERS COULD NOT UNDERSTAND WHY THE COCA-COLA UNION IN GUATEMALA CITY HAD NOT ORGANIZED THE OTHER NON-UNION COCA-COLA PLANT (THERE ARE TWO COCA-COLA PLANTS OUTSIDE GUATEMALA CITY; ONE IS UNIONIZED AND CURRENTLY IN AFFILIATION DISCUSSIONS WITH THE CUSG; THE OTHER IS NON-UNION);

-- CUSG LEADERS COULD NOT UNDERSTAND WHY THE UNION AT THE GUATEMALA CITY PLANT WAS SO UNAWARE OF THE POOR FINANCIAL SITUATION OF THE COMPANY; AND

-- TO THEIR KNOWLEDGE, MANAGEMENT-LABOR RELATIONS AT THE COCA-COLA PLANT HAD BEEN GOOD SINCE THE 1980 FRANCHISE CHANGE (LABATT HAD MADE THIS SAME POINT IN EMBASSY BRIEFING).

WITH RESPECT TO THE TRADE-UNION SITUATION IN GUATEMALA, THE CUSG LEADERS PAINTED A BLEAK PICTURE. THEY NOTED THE RECENT DISAPPEARANCES OF NUMEROUS LEFTIST TRADE-UNION LEADERS WHICH, THEY SAID, CREATED A CLIMATE OF FEAR AND MADE IT DIFFICULT FOR ALL TRADE-UNION LEADERS AND ORGANIZING EFFORTS. THE CUSG, THEY POINTED OUT, HAD VIGOROUSLY PROTESTED THESE DISAPPEARANCES TO THE GOG AND IN PUBLIC ADS. ANOTHER NEGATIVE TRADE-UNION FACTOR, THEY NOTED, WAS THE ANTI-

TOWARD THE END OF THEIR VISIT, BILL PATTERSON AND PAT DERIAN CAME TO THE EMBASSY TO DISCUSS THEIR FINDINGS WITH EMBOFFS. WITH RESPECT TO THE COCA-COLA WORKERS, MR. PATTERSON SAID THAT THE DELEGATION FELT REASSURED ABOUT THEIR PERSONAL SECURITY, EVEN THOUGH THE MINISTER OF INTERIOR

HAD CONFIRMED THAT THE GOVERNMENT HAD THE PLANT AND WORKERS' HOMES UNDER SURVEILLANCE. BOTH OF THEM EXPRESSED ADMIRATION FOR THE DISCIPLINED MANNER IN WHICH THE WORKERS WENT ABOUT THEIR BUSINESS OF OCCUPYING THE PLANT AND SAID THERE WERE NO OVERT POLITICS IN EVIDENCE THERE; THE WORKERS, THEY SAID, WERE KEEPING THE PLANT IN BEAUTIFUL CONDITION AND IT APPEARED THAT COCA-COLA PRODUCTION COULD BE RESUMED IN SHORT ORDER. MS. DERIAN EXPRESSED CONCERN THAT MANY MANAGEMENT-LABOR PROBLEMS IN GUATEMALA HAD BEEN SOLVED BY VIOLENCE IN THE PAST; SHE CITED THE HISTORY OF THE VIOLENCE IN THE COCA-COLA PLANT IN GUATEMALA WHERE EIGHT WORKERS HAD LOST THEIR LIVES IN PLANT DISPUTES. EMBOFF ASKED FOR CLARIFICATION ON THIS POINT AND NOTED THAT THESE DEATHS HAD OCCURRED IN 1980 AND BEFORE THE PRESENT FRANCHISE OWNERS HAD BEGUN OPERATING THE PLANT. SHE REPLIED THAT FRAGMENTED AUTHORITY AMONGST SECURITY FORCES OFTEN LED TO UNDISCIPLINED ACTS OF VIOLENCE BY SUBORDINATES, WHO NEVERTHELESS WERE THEN PROTECTED BY THE TOP. THE DELEGATION HAD ASKED THE INTERIOR MINISTER, SHE SAID, TO MAKE SURE, WHEN THE COCA-COLA PLANT PROBLEM WAS RESOLVED, THAT THE SECURITY FORCES WERE MADE TO UNDERSTAND THAT THE WORKERS HAD NOT BEEN CHARGED WITH ANY CRIME AND WERE NOT SUBVERSIVES. IF THE PROBLEM HAS A PEACEFUL RESOLUTION, SHE ADDED, IT WILL BE A HOPEFUL SIGN OF AN IMPROVEMENT IN MANAGEMENT-LABOR RELATIONS IN GUATEMALA.

ATMOSPHERE FOR THE TRADE-UNION MOVEMENT IN GUATEMALA IS NEGATIVE BECAUSE OF THE RECENT DISAPPEARANCES OF TRADE-UNION LEADERS. MANY PEOPLE IN THE LABOR MOVEMENT WITH WHOM THE DELEGATION TALKED ARE PESSIMISTIC AND DATE THE DOWNTURN FROM THE AUGUST COUP; MOST OF THESE TRADE-UNION LEADERS, HE STATED, FELT THE MEJIA GOVERNMENT WAS MORE REPRESSIVE THAN THE RIOS GOVERNMENT. MR. PATTERSON EXPRESSED DISAPPOINTMENT AT THE MINISTER OF LABOR'S POINT OF VIEW THAT THE WORKERS' OCCUPATION OF THE COCA-COLA PLANT WAS AN ACT OF REBELLION. HE WENT ON TO SAY THAT HE THINKS THE LABOR MINISTER DOES NOT HAVE A VERY SUBTLE NOTION OF LABOR RELATIONS AND DOES NOT APPEAR ABLE TO DISTINGUISH BETWEEN TRADE UNION ORGANIZING EFFORTS AND OPPOSITION TO THE GOVERNMENT.

WITH RESPECT TO RECENTLY-DISAPPEARED TRADE-UNION LEADERS, THE DEBRIEFERS ASKED THAT THE EMBASSY INQUIRY ABOUT THEIR WHEREABOUTS. INFORMATION LED THEM TO BELIEVE THAT THE ARMY WAS HOLDING FERNANDO GARCIA (CAVISA UNION OFFICER) AND THAT HE WAS ALIVE AND WELL. IN ADDITION TO MR. GARCIA AND THE OTHER ABDUCTED TRADE-UNIONISTS ON THE DELEGATION'S LIST, MR. PATTERSON ASKED THE EMBASSY TO LOOK INTO THE SITUATIONS OF TRADE-UNIONIST JOSE LUIS VILLAGRAN, WHO DISAPPEARED ON FEBRUARY 11, 1984 IN ZONE 11 AND THE CASE OF FRANCISCO ENRIQUE MOYA LUCAS (16 YEAR-OLD BROTHER OF A COCA-COLA WORKER), WHO DISAPPEARED ON MARCH 9 WHILE ON HIS WAY TO SCHOOL. GRAVITY WITH WHICH THE CASE IS VIEWED IN THE UNITED STATES. MS. DERIAN STATED THAT THIS WAS A SHAME BECAUSE IN HER TENURE AS ASSISTANT SECRETARY OF STATE FOR HUMAN RIGHTS IN THE CARTER ADMINISTRATION THE POLICY HAD BEEN TO MAKE "REPRESENTATIONS" TO HOST GOVERNMENTS IN HUMAN RIGHTS CASES AND TO REMIND THEM OF THEIR OBLIGATIONS UNDER THAT CORPUS OF INTERNATIONAL LAW TOUCHING ON HUMAN RIGHTS. THE CHARGE RESPONDED THAT IN THE GUATEMALAN CONTEXT WE ARE LIKELY TO HAVE MORE SUCCESS IN PURSUIT OF OUR CLEAR OBJECTIVES IN FAVOR OF HUMAN RIGHTS IF WE APPEAL TO GUATEMALANS' SELF-INTEREST IN HAVING A GOOD INTERNATIONAL IMAGE THAN IF WE SIMPLY DEMAND THAT THE GOVERNMENT MEET ITS COMMITMENTS UNDER INTERNATIONAL LAW.

6. COMMENT. THE COCA-COLA COMPANY CASE IS NOW IN LITIGATION BEFORE THE GUATEMALAN LABOR COURT. THERE ARE RUMORS THAT ANOTHER GUATEMALAN COMPANY HAS PURCHASED THE COCA-COLA FRANCHISE AND WILL RESUME PRODUCTION IN GUATEMALA CITY; PURPORTEDLY, IT IS NOT INTERESTED, HOWEVER, IN REHIRING THE OLD WORKERS. IF THIS IS TRUE, IT WILL ONLY FUEL SPECULATION THAT THE WHOLE FEBRUARY 14 BANKRUPTCY MOVE WAS A UNION-BUSTING TACTIC.
