4. (C) OUR 1997 HUMAN RIGHTS REPORT STRONGLY CRITICIZED THE COLOMBIAN GOVERNMENT FOR ITS FAILURE TO CONFRONT PARAMILITARY ORGANIZATIONS, AND OUR DRAFT REPORT FOR 1998 DOES AS WELL. ALL INDICATIONS ARE THAT PARAMILITARISM HAS CONTINUED TO GROW DURING THE PASTRANA ADMINISTRATION, AND THAT THE GOVERNMENT HAS DONE LITTLE TO CONFRONT THEM. REF (B), RECEIVED A LITTLE OVER A WEEK AGO, STATES THAT SECURITY FORCES DID NOT INTERVENE DURING 19 SEPARATE ATTACKS IN WHICH 143 CIVILIANS WERE KILLED OVER FOUR DAYS IN JANUARY.
