- -- ELN UNITS BLEW UP THREE SEPARATE TOLL BOOTHS ALONG THE ROAD FROM AGUACHICA TO EL COPEY, CESAR DEPARTMENT ON THE NIGHT OF JUNE 25, CAUSING DAMAGES AND LOSSES OF OVER 8 MILLION PESOS (21,000 USDOLS) BUT NO INJURIES.

LOSSES FROM THIS ATTACK WERE ESTIMATED AT 20 MILLION PESOS (52,600 USDOLS). THIS WAS THE FIFTH SUCH ATTACK ON THE PACIFIC PIPELINE IN THE PAST SIX MONTHS.

9. (U) ON JUNE 28, THE ATTORNEY GENERAL'S OFFICE ANNOUNCED THAT THE COMMANDER OF AN ELN FRONT, SEGISMUNDO HERRERA LIZCANO (AKA "LORENZO"), HAD BEEN RELEASED FROM CUSTODY. HERRERA HAD BEEN CAPTURED BY MILITARY UNITS ON JUNE 11 WITH 15 MILLION PESOS (40,000 USDOLS) AND HAD BEEN CHARGED WITH BLOWING UP THE CANO LIMON-COVENAS OIL PIPELINE, AMONG OTHER TERRORIST ACTS (SEE BOGOTA 8834, PARA 4). THE JUDGE RULED THAT HERRERA'S RIGHTS HAD BEEN DENIED BECAUSE HE HAD BEEN HELD BY THE MILITARY FOR ELEVEN DAYS BEFORE BEING HANDED OVER TO A JUDGE. LAW REQUIRES THAT DETAINEES BE TURNED OVER TO A JUDGE WITHIN 24 HOURS OF DETENTION. (COMMENT: SEVERAL NEWSPAPER ARTICLES HAVE CREDITED INFORMATION OBTAINED FROM HERRERA'S CAPTURE WITH THE MILITARY'S ABILITY TO LAUNCH ITS OFFENSIVE AGAINST THE ELN.)

## TWO MORE UP LEADERS ATTACKED, ONE KILLED

10. (U) THE VICE-PRESIDENT FOR META DEPARTMENT OF THE LEFTIST PATRIOTIC UNION (UP) PARTY, RICARDO RODRIGUEZ HENAO, WAS INJURED WHEN HIS APARTMENT WAS BOMBED IN THE MIDDLE OF THE NIGHT OF JUNE 23. RODRIGUEZ IMMEDIATELY WENT ON RADIO TO ACCUSE WELL-KNOWN NARCO AND EMERALD TRAFFICKER VICTOR CARRANZA, OF PERPETRATING THE ACT. RODRIGUEZ WAS THE LAWYER DEFENDING THE FAMILIES OF VICTIMS FOUND IN A MASS GRAVE ON A FINCA OWNED BY CARRANZA NEAR PUERTO LOPEZ, META AND THE FAMILIES OF 17 PEOPLE MASSACRED NEAR EL CASTILLO, META LAST FEBRUARY CONFIDENTIAL
