1020ZI. GEN SITUATION. CALM.II. FACTIONAL ACTIVITIES.

A. POLITICAL. SRSG AND FC HAD A MEETING WITH THE US AMBASSADOR ON 101600 JAN 94 AT UNAMIR HQ. THE TANZANIAN AMBASSADOR AND THE OAU REPRESENTATIVE ORGANIZED A MEETING WITH BOTH WINGS OF THE PL PARTY IN ORDER TO HELP IN THE IMPASSE. THE MEETING WAS TO RESUME THIS MORNING.

B. MILITARY.(1) RGF. NTR.(2) RPF. NTR.

(3) OTHERS. US EMBASSY AND UNITED STATES MILITARY PERSONNEL FROM THE U.S. NAVAL SCHOOL FOR JUSTICE COMMENCED AN EXECUTIVE SEMINAR ENTITLED "THE ROLE OF THE MILITARY IN A DEMOCRACY" IN KIGALI, RWANDA AT THE RWANDAN MILITARY'S TRAINING SCHOOL. THE SEMINAR ENDS ON 21 JAN 94 AND IN TOTAL 100 OFFICERS FROM RGF AND RPF ARE GOING TO ATTEND.

III. OWN MILITARY ACTIVITIES.

A. HQS. A SIGNIFICANT AMOUNT OF INFORMATION WAS PROVIDED BY AN INFORMANT ON THE INTERAHAMWE POLITICAL MILITIA. STAFFING ON THIS INFORMATION IS ONGOING.

B. SECTORS.

(1) KIGALI. CONDUCTED VEHICLE AND FOOT PTL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. CONFISCATED ONE RIFLE. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, THE PREMATURE, FORCE HQ AND SEC HQ. DURING THE NIGHT ASSURED PROTECTION FOR THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT AND FIVE OPPOSITION MINISTERS. PLANNING CONTINUED FOR POSSIBLE SWEARING-IN CEREMONIES OVER NEXT FEW DAYS.

(2) DMZ. CONDUCTED ROUTINE PTL IN OAR. CONTACT WAS MADE WITH THE MAYOR OF MUTURA (3223) AND THE POPULATION OF RENSENGE (3726). NO ARMS DISTRIBUTION REVEALED IN THE MENTIONED AREA. REPORTED AN INCIDENT THAT HAPPENED ON 102000 DEC 93 AT KINIGI (5440). A CIVILIAN WAS ATTACKED IN HIS HOUSE BY TWO RGF SOLDIERS. THEY USED THEIR ARMS, INJURED THE MAN AND RUN AWAY WITH SOME PERSONAL BELONGINGS. INVESTIGATION WILL BE DONE.

C. MILOB. CONDUCTED ESCORTS FOR RPF DELEGATES TO THE US EMBASSY SEMINAR. RGF AND RPF SECTORS CONDUCTED RECCE OF OAR.

D. UNOMUR. CONDUCTED ROUTINE PTL IN OAR. FC/CMO DID NOT GET A MEETING ORGANIZED WITH MINISTER OF DEFENCE AND CHIEF OF STAFF UNTIL TOO LATE TO BE ABLE TO GET TO KAMPALA. ATTEMPTS FOR LATER THIS WEEK ONGOING. THE DELAY IN THE ARRIVAL OF THE HELICOPTERS IS SERIOUSLY AFFECTING OUR OPERATIONAL CAPABILITIES IN MEETING THE OBJECTIVES OF OUR MANDATE.
