SITREP COVERING PERIOD 120600Z JAN TO 130600Z JAN 94.

I. GEN SITUATION. CALM. HOWEVER AT 122130 JAN 94 AN OBJECT WAS THROWN IN A BELGIAN PATROLLING JEEP. THE PERSONNEL JUMPED OUT OF THE VEHICLE THINKING IT WAS A GRENADE. FORTUNATELY IT WAS A STONE.

II. FACTIONAL ACTIVITIES.

A. POLITICAL. SRSG HAD THE FOLLOWING MEETINGS: AT 10.30 HRS WITH THE BELGIAN AMBASSADOR AND WITH THE CHARGE D'AFFAIRES OF FRANCE; AT 11.45 HRS WITH THE PRESIDENT OF THE REPUBLIC AND AT 16.00 HRS WITH THE PRESIDENT AND THE NATIONAL SECRETARY OF THE MRND PARTY.

B. MILITARY.

(1) RGE. CARRIED OUT PARA DROPPING PRACTICE AROUND KIGALI CITY. SUPPORT BEING PROVIDED BY BELGIAN C-130.

(2) RPE. NTR.

(3) OTHERS. US EMBASSY SEMINAR ON "THE ROLE OF THE MILITARY IN A DEMOCRACY" ONGOING.

III. OWN MILITARY ACTIVITIES.

A. HQS. STAFFING ONGOING ON ENHANCING EXISTING SECURITY. "IN" BRIEFING WAS ORGANIZED FOR 10 UNMOB FROM EGYPT THAT ARRIVED ON 11 JAN 94. SCHEDULED MEETING AT NGONDRE (0529) BETWEEN RGF AND RPF HAS BEEN POSTPONED TILL 14 JAN 94.

B. SECTORS.

(1) KIGALI. CONDUCTED VEHICLE AND FOOT PTL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, THE PREMATURE, FORCE HQ AND SEC HQ. DURING THE NIGHT ASSURED PROTECTION FOR THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT AND FIVE OPPOSITION MINISTERS.

(2) DMZ. CONDUCTED ROUTINE PTL WITHIN OAR.

C. MILOR CONDUCTED DECOY ALONG DMZ BORDER. CONDUCTED ESCORT FOR TANZANIAN AMBASSADOR TO GATUNA AND FOR UNICEF/ICRC TO BUGWE AND MIYOVE. STARTED FAMILIARIZATION TRAINING FOR THE NIGERIAN UNMOB THAT ARRIVED ON 10 JAN 94.

D. UKROMU. CONDUCTED NIGHTTIME PTL WITHIN OAR. ONE TRUCK WITHOUT ANY DOCUMENTS ENTERED THE BORDER AT KASHEKYE CARRYING MAIZE TO RWANDA. THE NRA WAS RELUCTANT TO CHECK
