I. GEN SITUATION. CALM.

II. FACTIONAL ACTIVITIES.

A. POLITICAL. BROAD BASED TRANSITIONAL GOVERNMENT NOT YET INSTALLED. NEGOTIATIONS ONGOING. SRSG HAD A MEETING WITH SEVERAL AMBASSADORS.

B. MILITARY.

(1) RGF. CARRIED OUT FIRING PRACTICE AT CANOMBE ON 14 JAN 94.

(2) RPF. RPF CHAIRMAN HOLD A PRESS CONFERENCE ON 141730 JAN 94 AT CND BUILDING.

(3) OTHERS. US EMBASSY SEMINAR ON "THE ROLE OF THE MILITARY IN A DEMOCRACY" ONGOING.

III. OWN MILITARY ACTIVITIES.

A. HQS. FC AND PLANNING SEC FORCE HQ WENT TO NGONDORE FOR A WORKING GROUP MEETING OF THE JOINT MILITARY COMMITTEE. CHIEFS OF STAFF OF RGF AND GENDARMERIE WERE EXPECTED BUT DID NOT SHOW UP.

B. SECTORS.

(1) KIGALI. CONDUCTED VEHICLE AND FOOT PTL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. ESTABLISHED 4 CHECK POINTS AT DIFFERENT PLACES IN KWSA. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, THE PREMATURE, FORCE HQ AND SEC HQ AND PROVIDED SECURITY TO THE AIRPORT OF KIGALI. DURING THE NIGHT ASSURED PROTECTION FOR THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT AND FIVE OPPOSITION MINISTERS.

(2) DMZ. CONDUCTED LONG DISTANCE PTL ALONG RUHENGERTI, KIDAGO, NKUMBA, NTARUKA AND KALINGORERA. PROVIDED ESCORTS FOR SWISS ENGINEERS SURVEYING THE ROADS IN AREA AROUND BULARIA. PROVIDED ESCORT FOR RGF REPRESENTATIVES TO A MEETING OF THE FOLLOW UP AND CONTROL COMMISSION FOR RELIEF DISTRIBUTION. PROVIDED SECURITY AT NGONDORE.

C. MILOB. CONTINUE RECCE WITHIN OAR. CONDUCTED ESCORT FOR RPF FROM/TO MULINDI AND FOR A WORLD FOOD PROGRAM CONVOY FROM GATUNA TO KIGALI. FAMILIARIZATION TRAINING OF NEWLY ARRIVED INMOs ARE ON PROCESS.

VII. LOGISTICS. OPERATIONAL SITUATION REMAINS DIFFICULT DUE TO THE LACK OF VEHICLES AND RADIOS. TWO CONTAINERS WITH MILITARY GOODS ARRIVED AT KIGALI FROM DAR ES SALAAM. WE ARE LOOKING FOR A SOLUTION FOR COMMUNICATIONS WITH DAR ES SALAAM IN THE FRAMEWORK OF THE SHIP UNLOAD AND TRANSPORT OPERATIONS TO KIGALI. DELAY IN INSTALLATION OF BROAD BASED TRANSITIONAL GOVERNMENT CREATES LOGISTICAL SUPPORT PROBLEMS FOR THE RPF BATTALION INSTALLED IN KIGALI CITY. NO GOVERNMENT NO BUDGET. RPF BEING TEMPORARILY SUPPORTED BY UNAMIR.

VIII. MISC.

- A. ON 140700 JAN 94 AN ACCIDENT TOOK PLACE BETWEEN A BELGIAN MILITARY MOTORCYCLE AND A PEDESTRIAN. BOTH PERSONS HAD MINOR INJURIES.
- B. IT IS REPORTED BY RPF LIAISON OFFICER THAT ON 141045 JAN 94 RPF SOLDIERS AT NURABA MUTARA AREA FIRED AT RETURNING REFUGEES IN AN ATTEMPT TO CONFISCATE THEIR ANIMALS. RPF CAME TO THEIR RESCUE AND RECOVERED THE ANIMALS. RPF WITHDRAW TO THEIR POSITIONS AND STARTED SHELLING THE AREA WITH 82 MM GUN. THIS SHELLING SCARED AND SCATTERED THE RETURNEES WHO ARE TRYING TO SETTLE.
- C. AT ABOUT 20.30 HRS 3 SMALL ARMS SHOTS WERE HEARD ABOUT 1 KM SOUTH OF DMZ HQ AT BYIMBA. INVESTIGATION ONGOING.
