1. SUMMARY. RWANDAN PATRIOTIC FRONT CLAIMS THAT NEARLY 7,000 REFUGEES WITH ALMOST 10,000 HEAD OF CATTLE RETURNED FROM UGANDA TO RPF-HELD TERRITORY DURING JANUARY. UNHCR IS MAKING AN EFFORT TO ASSESS THEIR FOOD AND NON-FOOD NEEDS

OR A LIMITED

ASSISTANCE PROGRAM, IN RESPONSE TO GOVERNMENT AND RPF REQUESTS. RELIEF PLANNING IS COMPLICATED BY LACK OF STRUCTURES TO MAKE DECISIONS ON REFUGEE ISSUES PENDING FORMATION OF TRANSITION GOVERNMENT. THE ISSUE IS CLOSELY LINKED WITH THAT OF WAR-DISPLACED FROM THE RPF ZONE WHO STILL LIVE IN CAMPS AND DEPEND ON INTERNATIONAL ASSISTANCE. END SUMMARY.

THE RPF HAS REGISTERED AND COLLECTED DATA ON THE REFUGEES SPONTANEOUSLY RETURNING FROM UGANDA SINCE DECEMBER 28, 1993, TO THE TABAGWE SECTOR OF THE FRONTIER COMMUNE OF MUVUMBA, IN RPF-HELD TERRITORY. RPF REPORTS THAT, BY JANUARY 21, THERE WERE 1,921 FAMILIES NUMBERING 6,700 PEOPLE, WITH 9,100 HEAD OF CATTLE. MOST BECAME REFUGEES IN THE 1960'S AND HAVE NO KNOWLEDGE OF WHERE THEIR FAMILIES ORIGINATED FROM IN RWANDA. OTHERS, WHO FLED FOLLOWING THE OUTBREAK OF WAR IN 1990, COME FROM THE RPF-HELD ZONE. ALL HAVE LEFT THE NYAKIVALE REGION WHERE THEY WERE EITHER LOCALLY SETTLED (THE 1960'S REFUGEES) OR IN CAMPS (THE 1990'S REFUGEES). THE GROUP IS PRIMARILY MEN AND BOYS.

RBTURNEES DURING THE VISIT. SHE SAID THEY CLAIM THE LOCAL POPULATION IN UGANDA PUSHED THE REFUGEES TO RBTURN, SAYING THE ARUSHA ACCORD IS THERE, YOU CAN RETURN, AND WE WANT YOUR LAND. ASKED IF SHE BELIEVED THE MOVE WAS TRULY SPONTANEOUS, SHE RECALLED UNHCR THE VISIT IN LATE JANUARY OF UNHCR'S SPECIAL ENVOY TO THE REGION TO THE REFUGEE SITES IN UGANDA. HE REPORTED FINDING WIDESPREAD ENTHUSIASM FOR RETURN. SO, SHE SAID, SHE IS CONVINCED THE RPF DID NOT PUSH THE REFUGEES TO RETURN. ON THE OTHER HAND, SHE NOTED THE RPF WOULD HAVE HAD TO ALLOW THE RETURNEES ACROSS THE BORDER. (COMMENT: A UN FORCES SOURCE SAID THEY HAVE LOCATED BETWEEN TWO MINE FIELDS, SUGGESTING THEY MAY HAVE HAD SOME ASSISTANCE IN FINDING THEIR WAY, AS WBLL. END COMMENT.)

7. FOOD ASSISTANCE. THE JOINT MISSION OF FEBRUARY 3 LOOKED INTO FOOD NEEDS OF THE RETURNEES. THERE IS DISAGREEMENT OVER WHAT THE FOOD NEEDS MIGHT BE. CRS REPRESENTATIVE NOTED TO AMBASSADOR AND DCM THAT MOST OF THE CATTLE HERDERS ARE HIMA WHO LIVE ON MILK, MEAT, AND CATTLE BLOOD. THEREFORE, HE REASONED, AS LONG AS THEY HAVE THEIR CATTLE, THEY HAVE NO NEED OF INTERNATIONAL ASSISTANCE. UNHCR, ON THE OTHER HAND, SAID ITS OFFICE IN KAMPALA AFFIRMED THAT THE PEOPLE IN QUESTION, THOUGH THEY MIGHT ONCE HAVE LIVED SOLELY OFF THEIR CATTLE, NOW ARE HABITUATED TO CEREALS, BANANAS, AND MORE TRADITIONAL FOODS. IN A TENSE MEETING WITH UNHCR FEBRUARY 2, RPF INSISTED ON IMMEDIATE ASSISTANCE BASED ON THE DATA IT HAD TABLED. UNHCR AND PVO'S SAID THEY COULD NOT PROCEED UNTIL THEY HAD A THOROUGH POPULATION AND NEEDS ASSESSMENT. UNHCR PLANS ANOTHER MISSION TO THE SITE FEBRUARY 11.

8. TECHNICAL PROBLEMS. UNHCR SAID THAT ANY FOOD ASSISTANCE OPERATION WOULD BE DIFFICULT. THE SITE IS THREE AND ONE-HALF HOURS FROM KIGALI OVER UNMAINTAINED ROADS AND A LOG BRIDGE (THE OTHER WAS BLOWN UP IN THE WAR) THAT CAN TAKE ONLY A 6-TON TRUCK AT MOST. THE WFP OPERATION HAS ONLY 15-TON TRUCKS, SUGGESTING THEY WOULD HAVE TO DELIVER TO WAREHOUSES SOUTH OF THE BRIDGE FOR TRANSFER TO SMALLER VEHICLES. THE CURRENT GROUP WOULD NEED AN ESTIMATED 120 TONS OF FOOD PER MONTH, IF ALL REQUIRED
