SITREP COVERING PERIOD 200600Z JAN TO 210600Z JAN 94.

I. GEN SITUATION. CALM AND UNCHANGED.

II. FACTIONAL ACTIVITIES.

A. POLITICAL. THE HEAD OF STATE RECEIVED SUBSEQUENTLY THE PRIME MINISTER AND THE PRIME MINISTER DESIGNATE. HE ANNOUNCED TO BE READY FOR THE INSTALLATION OF THE BRIG WHEN THE POLITICAL PARTIES MDR AND PL WOULD HAVE RESOLVED THEIR INTERNAL PROBLEMS. HE ASKED TO ARRANGE A GOVERNMENT ASSEMBLY IN ORDER TO SHOW THE POPULATION THAT THE COUNTRY IS STILL GOVERNED. SRSG MET THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE AND THE MINISTER OF FOREIGN AFFAIRS IN RESTAURANT HELENICK AT 19.00 HRS.

B. MILITARY.

(1) RGF. RGF PARA BATTALION CARRIED OUT PARA DROPPING PRACTICE WITH SUPPORT OF BELGIAN C-130.

III. OWN MILITARY ACTIVITIES.

A. HQS. FC PROPOSED ANALYSIS AND OPTIONS REGARDING THE CURRENT SITUATION TO SRSG. MEETINGS WITH UNDP AND UNHCR ON THE RETURN OF REFUGEES FROM UGANDA INTO RWANDA ONGOING.

B. SECTORS.

(1) KIGALI. CONDUCTED VEHICLE AND FOOT PTL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. ESTABLISHED 4 CHECK POINTS AT DIFFERENT PLACES IN KWSA. PROVIDED 4 UNMO ESCORTS AND 3 ARMED ESCORTS TO RPF. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, THE PREMATURE, FORCE HQ AND SEC HQ AND PROVIDED SECURITY TO THE AIRPORT OF KIGALI. DURING THE NIGHT ASSURED PROTECTION FOR THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT AND FIVE OPPOSITION MINISTERS. AND TO THE RESIDENCE OF SRSG.

(2) DMZ. DFC VISITED DMZ SECTOR. CONDUCTED MEDIUM RANGE PTL IN UAR FROM BURENGERI TO CHYIRA, RAMBURA, KAKAKARA, NYABIRE.

D. UNOMIB. CONDUCTED ROUTINE PTL WITHIN CAR. ACTION UNDERTAKEN REGARDING THE REFUGEE PROBLEM FROM UGANDA INTO RWANDA. PTL FOCUSED ON POSSIBLE ASSEMBLY AREA. UGANDA/RWANDA BORDER CROSSING BEING ON THE INCREASE NOTHING UNNORMAL HAS BEEN OBSERVED.

V. HUMANITARIAN ACTIVITIES. THE TOTAL NUMBER OF BURUNDESE REFUGEES IN SOUTH RWANDA AMOUNTED TO 272,000. UNHCR AND PAM LOOKING FOR IMPROVEMENT OF FOOD DISTRIBUTION. IT WAS SAID ON A MEETING BETWEEN UNDP/UNHCR/NGOs THAT MILITARY TRAINING IN THESE CAMPS, MAINLY PHYSICAL TRAINING, STARTED AGAIN AFTER A PERIOD OF CEASE. GENDARMERIE WILL BE ASKED TO INTERVENE IN ORDER TO STOP THIS KIND OF ACTIVITIES.

VII. LOGISTICS. OPERATIONAL SITUATION REMAINS DIFFICULT DUE TO THE LACK OF VEHICLES AND RADIOS. A SECOND CONVOY WITH 50 VEHICLES LEFT DAR ES SALAAM AND IS EXPECTED TO ARRIVE AT KIGALI ON 24 JAN 94.
