I. GEN SITUATION. TENSE WITH THE RUMOUR OF RGF REPRISAL CN TUTSI POPULATION AT RUHENGERI BY 04 DEC.

II. FRACTIONAL ACTIVITIES.

a. POLITICAL. MEETING HELD BETWEEN RGF AND RPF UNDER THE ASPICS OF UNDP AT NGONDORE(0529) ON 03 NOV.

b. MILITARY.

(1) RGF.

(a) ON 30 NOV AT 2200 HRS ONE RGF SLDR AT GISENEY(1712) THREW A GRENADE IN A HOUSE INHABITED BY A TUTSI FAMILY KILLING ONE PERSON AND INJURED THREE INCLUDING TWO WOMEN.

(b) THERE IS A STRONG RUMOUR IN RUHENGERI THAT RGF WILL TAKE REPRISAL ACTIONS AGAINST THE TUTSI POPULATION BY 04 DEC.

(2) RPF. ON RECEIPT OF INFO FROM RGF ABOUT THE PRESENCE OF RPF IN KINIGI(5438) ON 02 DEC, UNMO TEAM WENT TO THE PLACE TO INVESTIGATE AND FOUND TWO CIVILIANS AND ONE UNIFORMED PERSON WHO RAN AWAY ON SEEING THEM. IT IS BELIEVED THAT THEY WERE FROM TUTSI TRIBE WHO TOOK SHELTER IN THE FOREST OUT OF FEAR OF REPRISAL FROM RGF. LOCAL PEASANT CLAIMED OF SEEING RPF COOKING FOOD IN THE FOREST. UNMOS ARE MONITORING THE SITUATION.

(3) OTHERS. JN TUNISIAN PLATOON AT KINIHIRA(8231) WHILE ON DEEP FOOT PATROL IN THE VOLCANO AND BAMBOO FOREST AS AN INVESTIGATION FOLLOW-UP OF THE MASS KILLINGS OF THE NIGHT OF 29/30 NOV, FOUND 5 DEAD CHILDREN'S BODIES AND ONE YOUNG GIRL IN A STATE OF SHOCK. THE RWANDAN FORCES HAD NOT ENTERED THE FOREST TO FOLLOW THE PERPETRATORS OF THE ATTACK. THERE WERE 6 OUT OF 9 CHILDREN REPORTED MISSING ON THE AFTERNOON PRECEEDING THE 29/30 NOV ATTACK. THE GIRL HAS BEEN MOVED TO THE RUHENGERI HOSPITAL. UNMOS ARE INVESTIGATING THE MATTER.
