SITREP COVERING PERIOD 290600Z MAR TO 300600Z MAR 94.

1. GEN SITUATION. THE SITUATION OBSERVED TO BE CALM SINCE THE LAST SET UP OF THE BBTG FAILED ON 28 MAR 94. FEW GRENADE EXPLOSIONS WERE HEARD IN KIGALI CITY.

2. POLITICAL ACTIVITIES. BROAD BASED TRANSITIONAL GOVERNMENT NOT YET INSTALLED. NEGOTIATIONS ONGOING. ON 291000 MAR 94 SRSG HAD A MEETING WITH REPRESENTATIVES OF THE RWANDESE PATRIOTIC FRONT, THE REPRESENTATIVE OF THE FACILITATOR, AMBASSADOR OF TANZANIA, THE AMBASSADORS OF FRANCE, BELGIUM, GERMANY, THE UNITED STATES, UGANDA, ZAIRE, THE CHARGE D' AFFAIRS OF BURUNDI AND THE PAPAL NUNCIO, DEAN OF THE DIPLOMATIC CORPS, AT THE RESIDENCE OF THE AMBASSADOR OF THE UNITED STATES. AT 1200 HRS SRSG MET WITH THE PRIME MINISTER, MRS. AGATHE UWILINGIYIMANA, TOGETHER WITH THE DIPLOMATIC CORPS, AT THE PRIME MINISTER'S OFFICE.

3. FACTIONAL ACTIVITIES

A. RGF. ON 29 MAR 94, TOTAL 100 RGF TROOPS CARRIED OUT PARA DROP TRAINING AT NYANDENGU AREA.

B. RPF NTR.

C. OTHERS (1) ON 291950 MAR 94, ONE GRENADE EXPLODED BESIDE A HOUSE NEAR BOULEVARD DE L'OUA IN NYAKABANDA AREA. NO ONE WAS INJURED OUT OF THIS EXPLOSION. UNCIVPOL IS INVESTIGATING. (2) ON 291920 MAR 94, SOUND OF TWO SHOTS AND 2 GRENADE'S EXPLOSION WERE HEARD IN THE VICINITY OF THE RESIDENCE OF MR. NGULINZIRA. A PTL WENT TO THE SPOT AND FOUND NOTHING. (3) ON 292105 MAR 94, A GRENADE EXPLOSION WAS HEARD NEAR HOTEL CHEZLANDO. RUTBAT IMMEDIATELY SENT A PTL AND FOUND THAT THE GRENADE EXPLODED WITHIN 100 YARDS FROM THE MAIN GATE OF AMAHORO STADIUM AND BEHIND A SMALL BAR. OUT OF THIS EXPLOSION ONE LADY WAS SLIGHTLY INJURED AND SHE WAS GIVEN FIRST AID BY RUTBAT. (4) ON 292130 MAR 94, KIBAT TROOPS HEARD THE SOUND OF TWO GRENADE EXPLOSION AT CYAHAFI AREA. KIBAT IMMEDIATELY SENT ONE PTL IN THAT AREA AND FOUND ABOUT 20 PERSONNEL IN THAT AREA ON THE ROAD. THOSE PEOPLE THREW STONES ON TO THE TROOPS OF KIBAT. KIBAT PTL ALSO INFORMED THAT OUT OF THE GRENADE EXPLOSION ONE CIVILIAN PERSON WAS INJURED. BESIDE THIS ONE CIVILIAN WAS ALSO INJURED OUT OF STABBING. THE INJURED PERSONNEL WERE EVACUATED TO KIGALI HOSPITAL BY THE PTL OF KIBAT.

4. OWN MILITARY ACTIVITIES

A. FORCE HQ. A/FC PAID A WORKING VISIT TO BYUBAT COY POSITION AT NGARAMA (B COY HQ) AND NKUMBA (C COY HQ) ON A BELL 212 HELICOPTER TEST FLIGHT. A/FC SAW OFF THE LAST BATCH OF KIBAT 1 TROOPS AT KIGALI AIRPORT.

B. UNCOMBAT. UNOMUR OPERATIONAL AREA IS REPORTED TO BE CALM. SECTOR KABALE AND KISORO CARRIED OUT PTLs IN OWN AOR. ALSO CARRIED OUT AERIAL RECONNAISSANCE FROM KABALE RIVER AREA (SQ 8650) TO LUBIRIZI AREA (SQ 2662) TO FIND OUT LANDING PLACES FOR THE HELICOPTER AND ALSO FOR PTLs FROM 291400 TO 291600 MAR 94. THE VEHICLES WHICH ARRIVED AT KAMPALA ON 22 MAR 94 HAVE NOT YET ARRIVED AT KABALE. TOTAL 12 VEHICLES OF WORLD FOOD PROGRAMME (WFP) HAVE ENTERED INTO UGANDA THROUGHOUT KATUNA AFTER DELIVERING FOOD STUFFS IN RWANDA. BORDER CROSSINGS AT GATUNA:

C. DMZ

(1) GENERAL SITUATION OBSERVED TO BE CALM. BYUBAT B COY BASED AT NGARAMA REPORTED THAT ONE MR NKERABIWI ATHANSE OF NYAGAHITA COMPLAINED THAT 2 SUSPECTED RPF PERS IN MUFTI ATTACKED HIM AT HIS RESIDENCE AT 282100 MAR 94. THE ATTACKERS FIRED SMALL ARMS BUT THERE WERE NO CASUALTIES. THE PERSON HANDED OVER EMPTY CASES AND ROUNDS OF AK-47 RIFLE WHICH HE SAID WERE USED BY ATTACKERS. INVESTIGATION CONTINUES. BYUBAT C COY PTL BASE REPORTED THAT 5 LOCALS WERE KIDNAPPED BY RPF AT BUTETE (A7145) AT 291200 MAR 94. SEARCH PARTY FROM PLATOON AT KINIGI DESPATCHED TO THAT AREA BUT THEY DID NOT FIND WHEREABOUTS OF CAPTIVES. INVESTIGATION ONGOING. AT ABOUT 291840 MAR 94 BYUBAT CHECK POINT AT KIDAHU ARRESTED A LOCAL (MR MUTANGA GERALD) SUSPECTED TO BE AN RPF SOLDIER, WITH AN EXPLOSIVE DEVICE. MENTIONED PER WAS LATER ESCORTED TO RPF POSITION AT SOJI (A751484) AT 2130 HRS, WHERE HE CAME FROM. MENTION DEVICE IS NOW WITH BYUBAT FOR FURTHER DISPOSAL. CGSO VISITED DMZ SECTOR HQ AND FORCE ENGR COY HQ.

(2) TEAM B CARRIED OUT PTLs IN AOR. TEAM C WENT ON PTLs IN GEN AREA RULINDO (9110). TEAM D ESCORTED SUB PREFECT OF KINIHIRA TO KINIHIRA AND BACK TO BYUMBA. TEAM F CARRIED OUT INVESTIGATION WITH UNMO TEAM RPF SECTOR MOHAMBO. TEAM VISITED HQ RPF BN 157 AT MUTOJO (B2353). INVESTIGATION COVER INCIDENT ON 26 MAR 94 IN MUVONGO COMMUNE. OUR SITREP 4C(1) DATED 28 MAR 94.

(3) BYUBAT A, B AND C COYS CONDUCTED MOBILE AND FOOT PTLs WITHIN THEIR AORs.

(4) FORCE ENGR COY PROVIDED SECURITY AT NGONDORÉ. PREPARATION OF BREAST WORK WITH SAND BAGS AT NGONDORÉ MEETING PLACE FOR SECURITY OF TROOPS CONTINUED. SEVEN PERS FROM CONSTR PLATOON CARRIED OUT CONSTR WORKS AT RUTBAT.

(1) RGF SECTOR. NTR.

(2) RPF SECTOR ON 29 MAR 94 ABOUT 200 OFFICERS AND MEN CONDUCTED MILITARY TRAINING ON THE FOOTBALL FIELD OF BUTARO. TWO LOUD EXPLOSIONS WERE HEARD NORTH OF MULINDI AT ABOUT 1415 HRS. RPF OFFICERS AT MULINDI CLAIMED THAT ANTI-TANK ROUNDS WERE FIRED FOR TRAINING PURPOSES.

(3) SOUTHERN SECTOR. TEAM 702 VISITED THE BWEYEYE REFUGEE CAMP AND THE NEW CAMP IN NYARWISHISHI ON 28 MAR 94. MANY CASES OF DYSENTERY, MALARIA AND MALNUTRITION HAVE BEEN OBSERVED IN THESE CAMPS. UNHCR IN CYANGUGU REPORTED THAT THEY ONLY SUPPLY FOOD ONCE A MONTH TO THEIR AO. ON 28 MAR 94 THE AUTHORITIES OF KIBUYE PREFECTURE HELD A MEETING IN KIBUYE. THE AIM OF THE MEETING WAS TO DISCUSS THE FAMINE PROBLEM IN THE PREFECTURE.

E. KIGALI SECTOR

(1) RUTBAT CARRIED OUT 4 FOOT PATROLS, 29 VEHICLES PATROLS AND 3 CHECK POINTS DUTIES. PROVIDED 6 VIP ESCORTS. 1 FOR SRSG, 1 FOR PM DESIGNATE, 1 FOR PRESIDENT OF THE CONSTITUTIONAL COURT, 1 FOR MR NGANGO, 1 FOR MINISTER OF FOREIGN AFFAIRS AND 1 FOR RPF PERSONNEL. RUTBAT MECH COY CARRIED OUT NIGHT TRAINING ON VIP ESCORTING WITH APC. KIBAT CARRIED OUT 5 FOOT PATROLS, 27 VEHICLES PATROLS AND 4 CHECK POINTS DUTIES. PROVIDED SECURITY TO THE KIGALI AIRPORT. ALSO PROVIDED SECURITY TO THE RESIDENCE OF MR. GULINZIRA BONIFACE AND MR. NGANGO. THEY EMPLOYED TWO APCs FOR THE SECURITY OF CND COMPLEX. PROVIDED FOUR ARMED ESCORT. 1 FOR PM, 2 FOR RPF, 1 FOR MINISTER OF FOREIGN AFFAIRS. BYUBAT GOLF PROVIDED SECURITY TO THE FORCE HQ AND KIGALI SECTOR HQ. ALSO PROVIDED SECURITY TO THE RESIDENCE OF SRSG, FM, PM DESIGNATE, MINISTER OF FOREIGN AFFAIRS, MINISTER OF SOCIAL AFFAIRS AND PRESIDENT OF THE CONSTITUTIONAL COURT. TUNISIAN COY CARRIED OUT 2 FOOT PATROLS, 5 VEHICLES PATROLS AND PROVIDED SECURITY TO THE CND COMPLEX. SECTOR KIGALI PROVIDED 7 UNMO ESCORTS, 4 FOR RPF, 2 FOR GENDARMERIE. 1 FOR RGF.

(2) ON 29 MAR 94 TOTAL 112 PERSONNEL FROM KIBAT LEFT KIGALI AIRPORT FOR BELGIUM AS A PART OF ROTATION OF KIBAT.

5. UNCIVPOL. GENERAL SITUATION OBSERVED TO BE CALM. ON 291830 MAR 94 A SERIOUSLY INJURED PERSON WAS FOUND, BESIDE THE STREET OPPOSITE CND, BY A POLICE MONITOR TEAM. THE MAN WAS INJURED ON HIS HEAD. HE WAS ATTACKED BY UNKNOWN BANDITS. THE PERSON WAS BROUGHT TO KIGALI HOSPITAL BY THE POLICE MONITOR TEAM. ON 291925 MAR 94 A POLICE MONITOR TEAM HEARD A EXPLOSION NEAR GENDARMERIE BRIGADE REMERA. THEY WENT, TOGETHER WITH GENDARMERIE TO THE SPOT. ONE GRENADE WAS THROWN ON THE "NOUVEAU MARCHE DE REMERA". 2 PEOPLE WERE INJURED. THE GENDARMERIE SUSPECT, THAT THERE WAS A MEETING OF INTERHAMWE IN PROGRESS, AT THIS SPOT. THE 2 INJURED PERSONS HAVE BEEN BROUGHT TO KIGALI HOSPITAL BY CIVPOL.

6. HUMANITARIAN ACTIVITIES. BYUBAT TROOPS AT KIDAKO PROVIDED SECURITY TO ICRC TO DISTRIBUTION FOOD. BYUBAT PTL BASE AT MIMULI ORG A CLEAN UP CAMPAIGN AT MIMULI MARKET.

7. CIVIL AFFAIRS. BYUBAT PLATOON AT CYUNGO WITH ASSISTANCE FROM CIVIL AUTH HELD A FORUM TO EDUCATE POP AT GITARE (A9323) AND MASOGWE (A9523) ON THE TASK OF UNAMIR TROOPS IN THE AREA.

8. LOGISTICS. LOG COY PROVIDED SECURITY TO THE UNAMIR WORKSHOP AND UNAMIR SUPPLY AND COMMUNICATION WAREHOUSE. DRY, FRESH AND FROZEN FOOD WERE ISSUED TO THE VARIOUS COMPONENTS OF UNAMIR AS USUAL. 4 PERSONNEL ARE DEPLOYED AT BYUMBA TO SUPPLY FOODS TO THE UNITS LOCATED THERE.
