HUALLAGA VALLEY GAVE A MOVING ACCOUNT OF THE DEATH AND DESTRUCTION CAUSED BY A MAJOR ARMY OPERATION AGAINST SENDERO LUMINOSO'S STRONGEST MILITARY COLUMNS. THE JOURNALIST AND SEVERAL OTHER COLLEAGUES, THE ONLY OUTSIDE GROUP TO HAVE PENETRATED INTO THE CONTESTED AREAS TO DATE, WERE CAREFUL TO STATE THAT THEY ONLY SAW SEVEN BODIES AND TWO GRAVES. WHILE THE CASUALTY TOLL MAY BE SIGNIFICANTLY HIGHER, THEY ARE CONCERNED THAT UNFOUNDED REPORTS OF "HUNDREDS OF DEAD" MAY DAMAGE THE CREDIBILITY OF CHARGES AGAINST THE ARMY AND MINIMIZE THE IMPACT OF THE INCIDENT. STILL, THE JOURNALIST COLLECTED AUDIO AND VIDEO EVIDENCE FROM AN ARMY OFFICER OF INDISCRIMINATE MILITARY ACTION THAT KILLED WOMEN, CHILDREN AND AGED PERSONS, AS TROOPS BURNED VILLAGES AND USED HELICOPTERS WITH ROCKETS AND MACHINE GUNS IN WHAT MAY BE AN ONGOING ARMY OPERATION.

3. THE JOURNALIST WHO FIRST BROKE THE HUANUCO JUNGLE MASSACRE STORY BRIEFED POLOFF ON APRIL 19 ON THE SITUATION IN THE AREA ONE DAY AFTER RETURNING FROM THE ZONE. [REDACTED]

[REDACTED] CONTACTED THE JOURNALIST ABOUT APRIL 14 WITH THE FIRST NEWS OF A POSSIBLE ARMY MASSACRE IN THE AUCAYACU REGION OF THE HUALLAGA VALLEY. [REDACTED] ASKED THE JOURNALIST TO VISIT THE AREA, AND A GROUP OF FIVE REPORTERS AND CAMERAMEN FLEW TO TINGO MARIA ON APRIL 17. THE JOURNALISTS WERE JOSEFINA TOWNSEND (CNN AND LOCAL CHANNEL 9), GILBERTO HUME AND ROBERTO MEDRANO (UNIVISION TV NEWS), CECILIA VALENZUELA, AND OSCAR MEDRANO ("CARETAS" WEEKLY MAGAZINE). THEY WERE ACCOMPANIED BY A DELEGATION FROM THE NATIONAL COORDINADORA FOR HUMAN RIGHTS AND OPPOSITION CONGRESSMAN AND FORMER CHAIRMAN OF THE CONGRESSIONAL COMMITTEE FOR HUMAN RIGHTS ROGER CACERES. THE DELEGATION WAS MET AT TINGO MARIA BY JOSE NALBARTE, OF THE

4. IN TINGO MARIA, THE DELEGATION MET WITH THREE REFUGEES FROM THE AUCAYACU AREA WHO CLAIMED TO HAVE SURVIVED AN ARMY OFFENSIVE IN THE AREA. THEY SAID THE MILITARY USED HELICOPTERS TO FIRE ROCKETS AND STRAFE THE POPULATION OF THE HAMLETS

8. IMPRESSED BY THE STORY, THE JOURNALIST ASKED IF SOMEONE COULD TAKE THEM ACROSS THE RIVER TO CONFIRM THE EVENTS FIRST HAND, BUT FOUND THAT NOT ONE OF THE FAMILY MEMBERS WOULD TAKE THEM FOR FEAR OF RUNNING INTO THE ARMY. THEY WERE ABLE TO FIND THE FARMHAND AND, AFTER MUCH CAJOLING AND PAYMENT OF USD 10.00, CONVINCED HIM TO TAKE THEM ACROSS THE RIVER. TO THEIR SURPRISE, SOME TEN FAMILY MEMBERS DECIDED TO JOIN THEM ONCE THEY SAW THAT THE JOURNALISTS WERE GOING ACROSS THE RIVER.

9. THE FARMHAND ASSURED THEM THE BODIES WERE "JUST UP THE RIVER A LITTLE WAYS," BUT THE TRIP WAS ABOUT 45 MINUTES UP RIVER AND AN HOUR ALONG A PATH THROUGH DENSE JUNGLE. THE GROUP OF SOME FIFTEEN PERSONS HIKE SINGLE FILE ALONG A JUNGLE PATH. NEARING AN OPENING IN THE JUNGLE GROWTH, THE GROUP OF JOURNALISTS WAS LITERALLY STOPPED IN THEIR TRACKS BY AN OVERPOWERING STENCH, FOLLOWED ALMOST AT ONCE BY A FLURRY OF FLAPPING BLACK WINGS AS DOZENS OF TURKEY BUZZARDS TOOK TO THE SKY AS THE PEOPLE BROKE INTO THE CLEARING. VILLAGERS RACED PAST THE JOURNALISTS, YELLING AND WAVING THEIR ARMS IN AN EFFORT TO DRIVE THE BUZZARDS OFF WHAT THE JOURNALISTS SUDDENLY REALIZED WERE SEVEN MOUNDS OF ROTTING, HALF-EATEN CORPSES.

10. THE VILLAGERS, CRYING AND WAILING, RAN FROM ONE CORPSE TO THE NEXT, TRYING TO IDENTIFY THE BODIES. [REDACTED] HAD ACCOMPANIED THE GROUP TO FIND [REDACTED] HIS 17-YEAR-OLD DAUGHTER. HE KNELT NEXT THE BODY OF A WOMAN, FACE UP AND SPREAD EAGLE, HER DRESS MATTED UP AROUND HER WAIST AND NAKED FROM HER HIPS DOWN. THE FACE HAD BEEN EATEN AWAY, BUT NEXT TO THE BODY WAS A BAG WITH SOME CLOTHING. INSIDE THE BAG, HE PULLED OUT A T-SHIRT WITH A MICKEY MOUSE LOGO, WHICH HE HAD GIVEN [REDACTED] AS A PRESENT. ANOTHER FATHER WAS REDUCED TO PRYING OPEN THE MOUTHS OF THE BODIES, HOPING TO RECOGNIZE HIS CHILD'S DENTAL WORK. DESPITE THE UNBEARABLE STENCH, [REDACTED] PUT HIS DAUGHTER'S BODY INTO A LARGE PLASTIC BAG.

11. IN THE MIDDLE OF THIS TRAGIC SCENE, THE GROUP WAS STARTLED TO HEAR THE SOUND OF A LIGHT PLANE FLYING PAST THE AREA. PANICKED THAT THE ARMY MIGHT BE RETURNING, THE VILLAGERS STARTED A MAD DASH TO THE RIVER, THE JOURNALISTS BARELY ABLE TO KEEP UP WITH THEM. THE PATH, A MUCH ROUGHER MUD-CLOGGED BARELY-DISCERNABLE TRAIL, TOOK THEM BACK TO THE BEACH IN ABOUT 15 MINUTES.

ROLLING FRONT HAD REACHED THE HAMLETS OF MOLLUMA, MOENA AND CARMEN ALTO BY APRIL 8, WITH VIRTUALLY EVERY HAMLET ALONG THE RIVER BEING "SEARCHED" BY THE ARMY. THE OPERATION WAS ONGOING WHEN THE JOURNALIST LEFT THE AREA ON APRIL 18.

17. THE OPERATION MAY HAVE BEEN SPARKED BY COMRADE MANCO'S HUNTING DOWN OF REPENTED FORMER SENDERISTAS. RIVAS CLAIMED THAT 15 "ARREPENTIDOS" HAD BEEN KILLED IN HUAMALIES AND 15 IN MANCHURIA IN THE MONZON VALLEY.

GROUPS IN LIMA. THE INFORMATION WAS LEAKED TO
THE CENTER LEFT DAILY "LA REPUBLICA," WHICH
INCORRECTLY REPORTED THE EVENTS AND EXAGGERATED
THE DEATH TOLL (REF C). OUR SOURCE WAS EMPHATIC

ANGRY THAT THE IMPACT OF THE REPORT HAD BEEN LOST -- A CORRECTION THAT JOURNALISTS COULD ONLY ACCOUNT FOR 13 CASUALTIES VICE THE HUNDREDS ORIGINALLY REPORTED MIGHT WELL LET THE ARMY OFF THE HOOK IN THE PUBLIC'S MIND.

20. THE JOURNALIST WAS ALSO INCENSED THAT THE COORDINADORA HAD SENT ATTORNEY GENERAL BLANCA NELIDA COLAN A LETTER ON APRIL 18 DEMANDING THAT SHE INVESTIGATE THE CASE. THE JOURNALISTS WERE STILL IN THE AREA AT THE TIME AND THE ARMY COULD HAVE TRIED TO STOP THEM FROM COMING BACK TO LIMA OR PERHAPS CONFISCATE THEIR AUDIO AND VIDEO TAPES.

21. COMMENT: JOURNALISTS HAVE PROMISED TO GIVE US FULL ACCESS TO VIDEO AND AUDIO TAPES TAKEN AT THE SITE OF THE MASSACRE. WE WILL ALSO MEET IN LIMA ON APRIL 20 WITH A PRIEST FROM THE AREA FOR TO OBTAIN HIS VIEWS ON WHAT HAPPENED AND CURRENT CONDITIONS IN THE AREA. THE COMBINATION OF ACCUSATIONS BY FAMILY MEMBERS AND INVESTIGATIVE JOURNALISM WILL INCREASE CALLS FOR A GOP INVESTIGATION.
