THE END USE MONITORING AGREEMENT MUST BE APPROACHED ON A CASE-BY-CASE BASIS. REF A PROVIDED RELEASE AUTHORIZATION FOR CN AID TO THOSE COLAR UNITS THAT SATISFY THE HUMAN RIGHTS REQUIREMENTS OF US LAW AND THE EUM AGREEMENT. THIS CABLE WILL PROVIDE THE GUIDELINES FOR INFORMATION REQUIRED FOR FURTHER CONSIDEBATION OF THE COLAR'S 12TH BRIGADE.

- 4. (C) DEPARTMENT REALIZES THE HARDSHIP IMPOSED UPON POST BY THESE FURTHER REQUIREMENTS BUT PLEADS NECESSITY. IF WE ARE TO RELEASE CN AID TO THE REMAINING UNITS UNDER CONSIDEBATION WE MUST HAVE A BASIS UPON WHICH TO MAKE SUCH A DETERMINATION. - 7. (C) AS A PATTERN OF HUMAN RIGHTS VIOLATIONS IS FIRST AND FOREMOST A COMMAND FAILURE, DEPARTMENT ALSO REQUESTS A COMMAND HISTORY (AT THE TIME OF THE ALLEGED ABUSE AND FOR, AT LEAST, THE PAST TWO YEARS) OF THE 12TH BRIGADE AS WELL AS COMMAND HISTORIES OF THE SUB-UNITS (BATTALION LEVEL) INVOLVED IN THE ALLEGED ABUSES.
