1. John Tietjen telephoned to confirm that Dr. [Redacted] would become the Deputy Assistant Director for Research and Development (Life Sciences) and Dr. [Redacted] will be transferred to the Office of Scientific Intelligence to replace Dr. [Redacted]. Dr. [Redacted] will take over as Chief of the Psychiatric Division on 14 October. Dr. [Redacted] is resigning effective 15 October and will be employed as an independent contractor for the remainder of this fiscal year. 25X1A9a 25X1A9a

2. At the Executive Committee meeting this morning the Director indicated that the President's Foreign Intelligence Advisory Board was going to interest itself in personnel security. We have been holding up our system as an example and the Director wants an independent audit done to make sure that we are, in fact, actually doing all the things that we say we are doing. This job has been assigned to the Inspector General. In addition to this audit, the Director wants a story on our polygraph program--why do we have it? why do we think it is effective, etc.? He wants several examples of different kinds showing where the polygraph has been of use to prove or disprove a point. (I have talked with Bob Bannerman about this and have asked him to pull together the polygraph information by 4 October.)

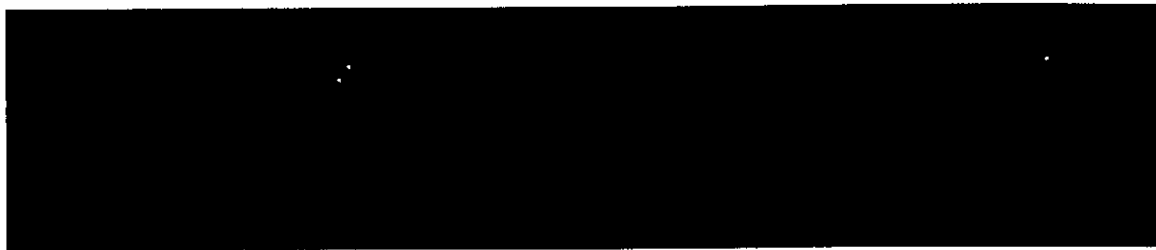
3. Jim Garrison reported that the owners of the property adjacent to our headquarters building have now agreed to accept a total of \$317,000. The financial details are as follows:

6. I confirmed with [redacted] that he would appreciate an opportunity to go to the Advanced Management Program at Harvard and have submitted his name for consideration by the Personnel Advisory Board for the February course.

7. In the interest of promoting our safety campaign, Emmett Echols proposed that we put a "Fasten Your Seat Belts" sign at each of our exits.

8. Mr. Kirkpatrick advised me that General Carter had delegated to him the authority to make decisions concerning downtown office space. Accordingly, I briefed Kirk today at which time he reaffirmed that this was the direction in which we should move. (See my Memorandum for the Record.)

9. Sherman Kent reported this morning that [redacted] would be coming on duty in his office on or about 1 January 1964. Emmett Echols has assured me that everything is in order for his entrance on duty and that there are no dual compensation statutes or other problems that we need worry about.

10. At the Executive Committee meeting this morning the Director reported that Mr. Hotz, the editor of Aviation Week, had been to see General Carroll. He told General Carroll that he had good information that another airplane, a follow-up for the U-2, had been developed. Carroll apparently

told Hotz that it would not be in the national interest to print anything on this, in response to which Hotz said that he was willing to sit on it provided everyone else did. In other words, he was not about to be scooped. The Director is seriously concerned that OXCART is going to blow sooner or later. It has great security implications as well as political implications and he has asked General Carter and Bud Wheelon to get at this with McMillan immediately. I have briefed Bob Bannerman and asked him to pull together the background on this and to get in touch with General Carter at his request.

12. I talked with Jack Barman about the Inspector General's report on TSD insofar as the MKDELTA program is concerned.
