[IN DATA FURNISHED BY YOU IN ORDER TO PROVIDE ADEQUATELY FOR CONCEALMENT OF YOUR SOURCES AND TO PREVENT JEOPARDY TO YOUR OPERATIONS IN MEXICO.] <sup>(u)</sup> YOU SHOULD ADVISE THE EMBASSY OFFICIAL THAT HE MAY FURNISH BUREAU INFORMATION TO PERTINENT U. S. OLYMPIC TEAM OFFICERS AT HIS DISCRETION ONLY WHEN SUCH INFORMATION IS APPROPRIATELY PARAPHRASED AND IF THE BUREAU IS NOT IDENTIFIED AS THE SOURCE OF THE DATA FURNISHED.

THIS MATTER MUST BE FOLLOWED CLOSELY TO INSURE FULLEST PROTECTION FOR THE AMERICAN ATHLETES CONCERNED. YOU SHOULD APPROPRIATELY ADVISE THE BUREAU OF INFORMATION FURNISHED TO THE U.S. EMBASSY FOR THIS PURPOSE, AS WELL AS NOTING THE IDENTITY OF THE OFFICER RECEIVING THE INFORMATION FROM YOUR OFFICE.
