3. ON APRIL 6, FIRST DEPUTY FOREIGN MINISTER
KURMANGUZHIN CALLED IN CHARGE TO DISCUSS NAZARBAYEV'S
VISIT. HE SAID NAZARBAYEV MIGHT VISIT ONE OR TWO OTHER
CITIES (COMMENT: THINKING ON THIS SEEMS INCHOATE).
REFERRING TO THE PROTOCOL INFORMATION WE HAD PROVIDED
EARLIER (REFTEL), KURMANGUZHIN ASKED IF KAZAKHSTAN WOULD
PAY FOR THE FUEL FOR NAZARBAYEV'S AIRPLANE. CHARGE
CONFIRMED THAT THIS WAS THE CASE. KURMANGUZHIN ASKED
WHETHER THE SIZE OF THE OFFICIAL DELEGATION COULD BE

- 4. KURMANGUZHIN ASKED WHETHER A PROGRAM COULD BE PLANNED FOR MRS. NAZARBAYEV. NOTING THAT SHE HEADED A CHARITY IN KAZAKHSTAN FOR CHILDREN'S HEALTH CARE, HE ASKED IF SHE MIGHT VISIT A CHILDREN'S HOSPITAL AND KINDERGARTEN. CHARGE SAID A SEPARATE PROGRAM COULD BE PREPARED FOR MRS. NAZARBAYEV.
- 5. KURMANGUZHIN THEN PLEAD FOR HELP IN PLANNING THE VISIT. NAZARBAYEV DID NOT WANT TO BE A "TOURIST." HE WANTED TO UNDERTAKE WHATEVER WOULD MAKE THE OVERALL VISIT A SUCCESS. THE KAZAKH GOVERNMENT FACED A MAJOR DIFFICULTY, HOWEVER, BECAUSE IT HAD NO REPRESENTATIVE IN THE RUSSIAN EMBASSY IN WASHINGTON, AND THE RUSSIAN EMBASSY ITSELF WOULD PROVIDE NO HELP. KURMANGUZHIN ASKED WHETHER THE U.S. SIDE COULD OFFER IDEAS FOR EVENTS, AND IDEAS ON WHAT MIGHT BE PROPER FOR NAZARBAYEV TO SAY PUBLICLY.
- 6. CHARGE SAID THAT, ON A PURELY PERSONAL BASIS, HE WOULD DEVELOP A FEW IDEAS. (SEE PARA. 12 BELOW.)

REMARKING THAT HE HAD MET WITH NAZARBAYEV THE PREVIOUS

- 8. IN THIS CONNECTION, SULEYMENOV SAID NAZARBAYEV ATTACHED "GREAT IMPORTANCE" TO THE FOUR ECONOMIC AGREEMENTS PRESENTLY UNDER DISCUSSION, I.E., THE TRADE, OPIC, BIT, AND TAXATION TREATIES. NAZARBAYEV WANTED ALL FOUR TO BE SIGNED DURING HIS VISIT. HE HOPED BOTH SIDES WOULD DO THEIR UTMOST TO MAKE THIS POSSIBLE. NOTING THAT U.S. AND KAZAKH EXPERTS HAD AGREED ON THE TRADE ACCORD DURING CONSULTATIONS IN MOSCOW ON APRIL 2, SULEYMENOV SAID NAZARBAYEV HAD AUTHORIZED THE KAZAKH SIDE TO BEGIN NEGOTIATIONS IMMEDIATELY ON THE THREE REMAINING TREATIES, EITHER IN ALMA ATA OR MOSCOW. COULD THE U.S. IMMEDIATELY SEND A NEGOTIATING TEAM IN RESPONSE TO THE K?SAKH PRESIDENT'S "URGENT PERSONAL REQUEST?"
- 9. CHARGE RESPONDED THAT THE U.S. ALSO ATTACHED GREAT IMPORTANCE TO CONCLUDING THE FOUR AGREEMENTS. HE WOULD CONVEY NAZARBAYEV'S REQUEST TO WASHINGTON. TIME WAS SHORT, HOWEVER, AND EVEN WITH THE BEST INTENTIONS, IT MIGHT NOT BE POSSIBLE TO CONCLUDE SEVERAL OF THE ACCORDS IN TIME FOR THE VISIT.

LOGISTICS OF THE VISIT -- AGAIN

11. RETURNING TO LOGISTICS, SULEYMENOV SAID THE KAZAKH DELEGATION WOULD CONSIST OF TWELVE MEMBERS PLUS TEN OTHER PEOPLE, I.E., A TOTAL OF TWENTY-TWO. NINETEEN WOULD STAY AT BLAIR HOUSE. SULEYMENOV AGAIN RAISED THE ISSUE OF EXPENSES. CHARGE CONFIRMED THAT THE KAZAKH SIDE WOULD BEAR ALL AIRCRAFT FUEL COSTS AND OTHER FEES. SULEYMENOV ASKED WHO WOULD PAY NAZARBAYEV'S VISIT EXPENSES AFTER THE WASHINGTON SEGMENT. CHARGE SAID THE U.S. WOULD BE RESPONSIBLE ONLY FOR THOSE EXPENSES OUTLINED IN REFTEL, AND ONLY FOR THE WASHINGTON SEGMENT OF THE VISIT. KURMANGUZHIN INTERJECTED, MISTAKENLY WE BELIEVE, THAT KAZAKHSTAN USUALLY PAID ALL EXPENSES OF VISITING HEADS OF STATE, BOTH WHILE TEY ARE IN ALMA ATA AND WHILE THEY ARE ELSEWHERE IN THE COUNTRY.
