1. THIS IS SSD-V-041. UNCLASSIFIED-ENTIRE TEXT.

- 2. SUMMARY. INTRODUCTORY DISCUSSIONS REGARDING SSD
 ASSISTANCE WERE HELD DURING SEPARATE MEETINGS WITH GOK MFA
 AND MOD OFFICIALS ON NOVEMBER 5 AND WITH THE STATE COUNSELOR
 FOR LEGAL AND DEFENSE AREAS ON NOVEMBER 6. THE HEAD OF
 DELEGATION, MAJOR GENERAL WILLIAM F. BURNS (RET), OUTLINED
 POSSIBLE PROGRAMS, SUCH AS MISSILE DISMANTLEMENT, EXPORT
 CONTROLS, MATERIAL CONTROL AND ACCOUNTABILITY (MC AND A),
 ACCIDENT RESPONSE AND GOVERNMENT-TO-GOVERNMENT
- ACCIDENT RESPONSE AND GOVERNMENT-TO-GOVERNMENT COMMUNICATIONS LINK (GGCL), AS WELL AS THE REQUISITE UMBRELLA AGREEMENT. GEN BURNS HIGHLIGHTED RUSSIAN ASSURANCES TO SHARE PROCEEDS OF HEU SALES WITH THE GOK AND OTHER START SUCCESSOR STATES. IN ALL MEETINGS, GOK REPRESENTATIVES WERE FULLY SUPPORTIVE OF PROPOSALS TO DEVELOP U.S./GOK AGREEMENTS. THEY AGREED TO PROVIDE THROUGH AMEMBASSY ALMA ATA IDENTIFICATION OF THOSE PROGRAMS OF SPECIFIC INTEREST. U.S. DEL AGREED TO PROVIDE DRAFT IMPLEMENTING AGREEMENTS FOR GOK CONSIDERATION PRIOR TO A DECEMBER VISIT TO WASHINGTON BY SIGNING AGREEMENTS. AMBASSADOR COURTNEY PARTICIPATED IN THE

DISCUSSIONS WITH MFA

MEETINGS. END SUMMARY.

- DISCUSSIONS WERE HELD WITH MFA OFFICIALS AT 3:00 PM, NOVEMBER 5 IN THE KAZAKHSTANI SUPREME SOVIET BUILDING. AFTER WELCOMING REMARKS AND INTRODUCTIONS, GEN BURNS BEGAN BY SUMMARIZING THE PROVISIONS OF THE NUNN-LUGAR LEGISLATION, AS WELL AS THE FREEDOM SUPPORT ACT. HE ALSO HIGHLIGHTED THE HEU AGREEMENT BETWEEN THE U.S. AND RUSSIA, EMPHASIZING RUSSIAN ASSURANCES THAT IT WILL SHARE PROCEEDS OF SALES WITH KAZAKHSTAN, UKRAINE AND BELARUS. DRAWING ON TALKING POINTS OF REFTEL, GEN BURNS THEN OUTLINED A PROPOSED PROGRAM OF ASSISTANCE, WHICH INCLUDED ACCIDENT RESPONSE, EXPORT CONTROLS, GGCL, MISSILE DISMANTLEMENT, AND MC AND A. STRESSING THAT THIS DID NOT EXHAUST THE POSSIBLITIES, BUT WERE RATHER AREAS FOUND TO BE FRUITFUL, GEN BURNS SUGGESTED THAT THE GOK CONSIDER THE PROPOSALS, DEVELOP OTHER AREAS OF POSSIBLE ASSISTANCE AND PASS THIS INFORMATION TO WASHINGTON THROUGH AMEMBASSY ALMA ATA.
- 4. DEPUTY FOREIGN MINISTER TOKAYEV EMPHASIZED THE IMPORTAXNCE OF SSD AND ACKNOWLEDGED THEIR OBLIGATIONS UNDER START AND THE INF TREATY, STATCG THERE IS NO QUESTION REGARDING GOK FULFILLMENT OF THESE OBLIGATIONS. HE FURTHER STATED HIS POSITIVE PERSONAL REACTION TO GEN BURNS' PRESENTATION AND DISCUSSED THE FOLLOWING CONCERNS.
- --COST OF MISSILE DISMANTLEMENT. GOK ESTIMATES COST OF DISMANTLING ONE RV TO BE APPROXIMATELY USDOLS 100,000.
 --HEU SALES PROCEEDS. SINCE KAZAKHSTAN SUFFERED DUE TO NUCLEAR TESTING DONE ON ITS SOIL AND SINCE MUCH OF THE URANIUM ORIGINALLY WAS MINED IN KAZAKHSTAN, THEY FEEL STRONGLY ABOUT RECEIVING A FAIR SHARE OF THE PROFITS. THEY

INDICATED THEY HAVE YET TO HOLD DISCUSSIONS WITH RUSSIA ON THIS SUBJECT BUT WERE PLEASED TO HEAR OF THE RUSSIAN COMMITMENT AND THE U.S. SUPPORT THEREOF.

5. THE KAZAKHSTANI SIDE RAISED THE QUESTION OF STATUS OF SSD AGREEMENTS WITH OTHER REPUBLICS, TO WHICH GEN BURNS REPLIED BY SUMMARIZING PROGRESS MADE WITH BELARUS, RUSSIA AND UKRAINE. GEN BURNS ALSO CLARIFIED THAT THE U.S. WILL FULLY FUND PROJECTS UNDER NUNN-LUGAR AND THAT THESE FUNDS DO NOT APPLY TO C

ONVENTIONAL WEAPONS.

6. THE MEETING ENDED ON A POSITIVE NOTE, WITH THE GOK SIDE STATING THAT IT WILL PRESS FORWARD AND EXPEDITE PROPOSALS MADE BY THE U.S.

 7. DISCUSSIONS WERE HELD WITH MOD OFFICIALS AT 5:00 PM,
 NOVEMBER 5 IN THE MOD BUILDING. GEN BURNS SUMMARIZED THE
 PROPOSED PROGRAM OF ASSISTANCE AND AGAIN SOLICITED INPUT
 FROM GOK THROUGH AMEMBASSY ALMA ATA, THE ONLY CRITERION
 BEING THAT PROPOSALS SPEED UP THE DISMANTLEMENT OF NUCLEAR
 WEAPONS AS PROVIDED IN START OR HELP PREVENT NONPROLIFERATION OF WEAPONS OF MASS DESTRUCTION OR THEIR
 COMPONENTS.
- 8. THE KAZAKHSTANI SIDE REAFFIRMED THEIR COMMITMENT TO BECOMING A NON-NUCLEAR STATE AND TO FULFILLING THEIR OBLIGATIONS UNDER START. THEY EMPHASIZED THAT ANY ASSISTANCE SHOULD BE FAIRLY DISTRIBUTED AMONG THE SUCCESSOR STATES.
- 9. GEN BURNS ANSWERED SEVERAL QUESTIONS. HE STATED THAT THE U.S. WILL ABIDE BY THE START TREATY PROVISIONS AND WILL MEET THE TIMETABLE PRESCRIBED. THE U.S. CAN PAY FOR TRAVEL, EQUIPMENT AND OTHER COSTS INVOLVED IN SSD PROJECTS. HE ALSO CLARIFIED THAT FUNDING APPLIES TO DELIVERY MEANS, AS WELL AS THE WARHEADS, THEMSELVES.
- 10. GEN BURNS OUTLINED THE NEED FOR AN UMBRELLA AGREEMENT AND THEN ASKED THAT THEY CONSIDER OUR PROPOSALS AND PROVIDE INPUT TO WASHINGTON THROUGH AMEMBASSY ALMA ATA.

DISCUSSIONS WITH STATE COUNSELOR SULEYMENOV

11. THE U..SIDE MET WITH STATE COUNSELOR FOR LEGAL/DEFENSE AFFAIRS SULEYMENOV AT 11:00 AM, NOVEMBER 6. MANY OF THOSE PRESENT AT THE NOVEMBER 5 MEETINGS ALSO ATTENDED AND IT WAS CLEAR THAT THE STATE COUNSELOR HAD BEEN THOROUGHLY BRIEFED ON THOSE MEETINGS. HE STATED THAT AFTER THE NOVEMBER 5

- MEETINGS HE HAD SPOKEN WITH PRESIDENT NAZARBAYEV AND WAS AUTHORIZED TO ACCEPT THE GENERAL PROPOSITIONS OF THE U.S. 12. BASED ON THE PERCEIVED LEVEL OF INTEREST SHOWN BY THE GOK, GEN BURNS MADE THE FOLLOWING SUGGESTION IN THE INTEREST OF COMPRESSING THE TIMETABLE TO REACH EXPEDITIOUS AGREEMENT ON ASSISTANCE:
- --THE U.S. SIDE WILL PROVIDE AMEMBASSY ALMA ATA WITH A LIST OF PROPOSED PROGRAMS AS DISCUSSED IN THE NOVEMBER 5 MEETINGS.
- --WITHIN THE NEXT TWO WEEKS, THE GOK WILL IDENTIFY AREAS OF INTEREST FROM OUR DISCUSSIONS AND ANY ADDITIONAL AREAS OF INTEREST TO AMEMBASSY ALMA ATA.
- --TWO TO THREE WEEKS LATER (EARLY DECEMBER) A 6-8 PERSON DELEGATION WOULD TRAVEL TO WASHINGTON DC TO FINALIZE AND SIGN THE UMBRELLA AND IMPLEMENTING AGREEMENTS. U.S. WILL PROVIDE DRAFT AGREEMENTS TO GOK PRIOR TO THE WASHINGTON TRIP.
- 13. THE GOK SIDE AGREED TO THIS PROPOSAL AND STATED THEY COULD MEET THE REQUIREMENTS OF SUCH A TIMELINE.
- 14. OF PARTICULAR NOTE WAS THE GOK INTEREST IN USING MISSILE SILOS FOR PEACEFUL PURPOSES, E.G., SMALL NUCLEAR POWER REACTORS OR GRAIN STORAGE. WHILE CONFIRMING THAT IN NO WAY WOULD THEY UNDERMINE START, THEY EXPRESSED AN INTEREST IN:
 --USING THE 12 TEST LAUNCH SILOS NOT COVERED UNDER START FOR THIS PURPOSE, AND
- --REVISITING THE START SILO DESTRUCTION QUESTION AFTER START ENTRY-INTO-FORCE.
- -- GENERAL BURNS, INDICATING THAT HE LACKED COMPETENCE TO DEAL WITH THE DETAILS OF START COMPLIANCE, STATED THAT HE WOULD REPORT GOK CONCERNS TO WASHINGTON.
- 15. DESPITE INITIAL DIFFICULTIES IN RECEIVING INVITATIONS TO VISIT AND SCHEDULING MEETINGS, THE GOK SEEMS FIRMLY SUPPORTIVE OF THE PROGRAM AND THE CREDIBILITY OF THE U.S.
